This Agreement made this fifth day of May A.D. 1873 between A. McLaurin, G. H. Hedges, A. Neil and B. C. Safford of the first part and George A. Cagre of Eureka in Eureka County State of Nevada of the second part Witnesseth that the parties of the first part for and in consideration of the sum of one dollar of the currency of the United States of America to them in hand paid the receipt whereof is hereby acknowledged and for divers other good causes and valuable considerations have agreed and do hereby contract and agree to and with the party of the second part to sell transfer and convey to him, all the right title and interest of the said parties of the first part in and to all that certain Mining location or claim, called and known as the Bug-out, located on or about the month of July A.D. 1869 situated in the Eureka Mining District Eureka County State of Nevada on Hoosack or Bald Mountain, directly North of the Hoosack and Banner Mines, and shall give to the party of the second part a good and sufficient deed of conveyance and transfer of all their right title and interest in the said Mining claim and location called the Bug-out

Condition that the party of the second part, shall at any time within six calendar months next ensuing the date hereof pay to them the said parties of the first part, the sum of One Thousand Dollars, in gold coin of the United States of America, for such deed of conveyance and transfer as aforesaid.
