with George A. Sayre

Article of agreement made and entered
into this eleventh day of June A.D. one thousand eight
hundred and seventy three, between Mark Roler of Custer
County and State of Colorado, of the ~~first~~ part and
George A. Sayre of the same place of the other part, as
follows, that the said Mark Roler doth hereby agree
with the said George A. Sayre to sell to him the following
described Mining interests to wit. First An undivided
interest of Two hundred and fifty (250) feet of Mining
ground in and upon that certain Mining claim
right and location known as, and called the Little

Mine situated in the Eureka Mining District, County of Eureka and state of Nevada and particularly described as being located on Woosac Mountain directly north of the Woosac Mine in said District and being the same property deeded this day to said Roler by said Sayre. and Second; An undivided interest of three hundred and thirty three and one third (333 $\frac{1}{3}$) feet of mining ground in and upon that certain mining claim right and location, known as and called the First Extension North of the Little Rosa Mine, situated in the Eureka Mining District, County of Eureka and State of Nevada and particularly described as ~~described~~ being located on Woosac Mountain directly north of the Woosac Mine in said District for the sum of three hundred and fifty (350) Dollars in U.S. Gold Coin and that he the said Mark Roler shall and will on or before the expiration of Ninety (90) days from this date to wit, on or before the 11th day of September A.D. 1873 on receiving from the said George A. Sayre the said sum, at his own cost and expense execute a proper conveyance for the conveying and assuring the title of the said premises to the said George A. Sayre free from all encumbrance which conveyance shall contain a general warranty (except as against the Government of the United States) and the usual full covenants.

And the said George A. Sayre agree with the said Mark Roler that he the said George A. Sayre shall and will on or before the said 11th day of September A.D. 1873 and on the execution of such conveyance pay unto the said Mark Roler the sum of Three Hundred and fifty (350) Dollars aforesaid in U.S. Gold Coin, And it is further agreed between the parties aforesaid as follows; The said George A. Sayre shall have and retain the possession of the said premises and work the same and receive and be entitled to the rents and profits thereof until the said 11th day of September when, if the said sum of money shall not be paid by the said Sayre he shall deliver up the possession thereof to the said Roler.

And it is understood that the stipulations aforesaid are to apply to and bind the heirs executors and administrators of the respective parties.

And it is hereby distinctly understood by and between the parties hereto that in the event of the failure of said George A. Sayre to pay the said sum of money at the time aforesaid to wit, the 11th day of September A.D. 1873 then and in that event the said Mark Roler shall be under no obligation either in law or equity to execute and deliver the conveyance aforesaid.
