

Partnership Agreement

A. Campbell & Co. By J. P. ...

between H. S. Bigby and A. O. O'Neil

Whereas H. S. Bigby hereinafter named and one of the parties to this Contract, is in the possession of an undivided interest of Two hundred (200) feet of Mining ground in and upon that certain Mine known as the "Pinkville" situated in the Eureka Mining District County of Eureka and State of Nevada; under and by virtue of an Agreement in relation thereto, made and executed by and between said Bigby and Edward Welch on the 20th day of March A.D. 1873; which agreement is recorded in the Records office of said County in Book A Miscellaneous page 14.

And Whereas A. O. O'Neil hereinafter named and one of the parties to this contract, is in the possession of an undivided interest of One hundred feet (100) of Mining ground in and upon the said Pinkville Mine under and by virtue of an Agreement in relation thereto made and executed by and between said O'Neil and one Edward Calnon on the 22nd day of April A.D. 1873 which agreement is recorded in the Records office of said County in Book A Miscellaneous page 16.

And Whereas the said Bigby and O'Neil are desirous of working said respective mining interests in common and as co-partners share and share alike. Notwithstanding the disparity of the respective interests possessed by each as aforesaid and mutually to bear and incur the responsibilities and burdens of the respective contracts aforesaid and share equally in the benefits, profits and advantages which may arise, accrue or flow from said contracts or either of them to the parties hereto or either of them.

Now therefore this agreement made and entered into at Eureka Nevada the seventh day of June A.D. eighteen hundred and seventy three and between said H. S. Bigby of Eureka County State of Nevada and A. O. O'Neil aforesaid of the same place.

Witnesseth that the said parties H. S. Bigby and A. O. O'Neil have become and now are the possessors of three hundred (300) feet of Mining ground undivided in and upon

last above written.
