




Maggie McEntyre & B. P. Esterly

This Agreement made and entered into this 15th day of September 1873 Between Maggie McEntyre of Sureka, Sureka County, State of Nevada party of the first part and Peter Esterly and August Riegelhaupt of the same place the parties of the second part Witnesseth that the said party of the first part agree to sell and convey upon the conditions hereinafter specified, to said parties of the second part for the sum of Fifty Dollars (\$50.00) United States Gold coin the following described property situate lying and being in Sureka County, Town of Sureka, Nevada State, & being Lot No 6 in Block No 7 of the Munroe Survey of said Town together with all & singular the tenements hereditaments and


apportionances thereunto belonging or appertain-
 ing. And the said parties of the second part hereby
 agree in consideration of the premises to pay said sum
 of (\$135.00) as follows to wit: the sum of Six Hundred
 and Seventy five Dollars upon the Execution of these
 presents and six Hundred and Seventy five Dollars
 on 15th day of December 1873. And said party of the
 first part hereby further agrees that upon the pay-
 ment to her by said parties of the second part of
 said sum at the time and in the manner herein
 specified that she will upon demand made by said
 parties of the second part their executors administrators
 and assigns make execute sign seal acknowledge &
 and deliver to said parties of the second part a good
 and sufficient Deed of Conveyance conveying and
 assigning to said parties of the second part their
 heirs Executors and administrators and assigns
 the above described premises free from all incumbrances
