J. W. Ellyson the defendant in the above entitled action do hereby Confess Judgment therein in favor of L. J. Hogle the said Plaintiff for the sum of two hundred seventy seven ^{49/100} dollars and authorize judgment to be rendered therefor against me with interest at the rate of two per cent per month from this date until paid on the sum of two hundred and forty two dollars. This Confession of Judgment is for a debt justly due and owing to the said Plaintiff arising upon the following facts, to wit: That on the 20th day of May A.D. 1873 I made executed and delivered to one J. J. Ferratt my two certain promissory notes for the sum of One hundred and twenty one dollars gold coin each and each bearing two per cent interest per month from said date until paid. Both of said notes are now due and have been assigned to the Plaintiff in said action who now holds and owns the same. That said notes were made in and at the Town of Eureka Eureka County State of Nevada and I have never paid any money upon said notes either principal or interest.
