On this 11th day of April A.D. 1875, comes the above named Plaintiff by his Agent J. J. Read and his said attorneys and has his complaint filed wherein he sets forth that the said Defendant Geo. D. Howell is indebted to him in the sum of Five hundred coin Dollars and interest on the sum of Two hundred Dollars of said sum from July 12th 1875 at the rate of three per cent per month, principal and interest due upon a certain promissory note made by Defendant to Plaintiff in words and figures following, to wit:

\$7300. Gold

Hamilton Jan'y 20 1872

Thirty days after date I promise to pay to the order of W. D. McCormick Three Hundred Dollars, Interest at Three (3) per cent per month until paid value received
 G. D. Howell

(Endorsement) Eureka Nevada July 12 1875. \$100. Recd one hundred Dollars on the within note.

Affidavit for attachment made by J. J. Read agent of Plaintiff and filed.

Undertaking on attachment in the sum of Two hundred coin Dollars, with two sureties taken approved and filed.

Summons and writ of attachment issued and placed in the hands of Constable S. R. Kelly for service.

Summons directed to Defendant and made returnable in the twelfth day of April A.D. 1875 at 2 o'clock P.M.

April 12th 1875, Summons returned endorsed served upon said Defendant Geo. D. Howell at Eureka Township said County and State on the 11th day of April A.D. 1875. Endorsement on return signed by S. R. Kelly as Constable and filed.

Writ of attachment returned endorsed served by Deoy upon Lot 3, Block 6, of Hamroes Survey of the Town of Eureka, together with the Improvements thereon endorsement signed by S. R. Kelly as Constable, and filed.

And now on this 12th day of April A.D. 1875, at the hour set for trial comes the said plaintiff into Court by his said attorneys, and having with the Court, waited one full hour, till, to wit: Three o'clock P.M. and the said Defendant having wholly failed to answer or appear Plaintiff moves for judgment by default against the said Defendant Geo. D. Howell for the sum claimed in said complaint, and the Court grants the motion.

Now therefore in view of the Law and the facts, it is ordered, considered and adjudged, that said Plaintiff

Plaintiff W. S. McCormick have and recover of and from said Defendant Geo. D. Howell the said sum of Three hundred and Dollars, and interest on the sum of Two hundred Dollars thereof at the rate of three (3) per cent per month in coin from February 12th 1875 till paid, and costs of this suit taxed at \$20.00 coin. And have this his judgment therefor.
