This agreement made between J S Merchant and J Money of Quicks Nevada and Uchiuda of the same place. Witnesseth that whereas said Merchant & Money have this day signed four (4) notes for \$328.- each payable in three (3) six (6) nine (9) & twelve (12) months to J Hatch & Co of San Francisco California said notes to be in full payment of the accounts and demands specified in the annexed schedule against said Uchiuda, and whereas said Uchiuda to secure said payments has this day caused to be executed a deed from Nicholas Noble to said Merchant and Money for Lot two (2) in Block One (1) in the Mc Coy survey of said town.

Now said Merchant and Money in consideration of the sum of one dollar to them in hand paid hereby agree that upon the payment of the sums specified in said promissory notes and interest as therein set forth, that they will release said Uchiuda from all of said demands (they said Merchant and Money being the assignees of said demands) and that they will reconvey said premises to said Noble or to whomsoever he may direct, Witness our hands and seals this 19th day of September A.D. 1874.
