This Indenture made the 19<sup>th</sup> day of June 1875. Witnesseth, that J. J. Work and Wm Van Alstine of Eureka County Nevada do hereby lease, demise and let unto J. B. McLeod of the same place all that certain piece or parcel

of land, situate, lying and being in Pleasant Valley, Eureka County, Nevada, and known as surveys fourteen and fifteen, to have and to hold for the term of twenty six months from the date hereof, yielding and paying therefor the rent of one dollar for the full term of said twenty six months, and the said lessee promises to pay the said rent in accordance with the terms herein, and the said lessee further promises, in consideration of the lease herein granted, to finish in a good substantial manner, upon the above named premises, the corral, a portion of which is already constructed, said corral to be constructed of stockades or poles, and when completed to contain four hundred feet of stockade fencing, said lessee promises to complete said corral in manner as above stated within twelve months from the date hereof, and to quit and deliver up the premises to the lessors or their agent or attorney, peaceably and quietly at the end of the term in as good order and condition, reasonable use and wear thereof, and damages by the elements excepted), as the same are now or may be put into, and not make or suffer any waste thereof, nor lease nor underlet nor permit any other person or persons to occupy or improve the same, or make or suffer to be made any alteration therein, but with the approbation of the lessors thereto, in writing having been first obtained, and that the lessors may enter to view and make improvements, and to expel the lessee if he shall fail in his promises, covenants and agreements herein, or make or suffer any strife or waste thereof.

And should default be made in any manner herein on the part of the lessee, the said lessors, their agent or attorney, three days after such default, may re-enter and take possession of said premises, and at their option terminate this lease.
