term of said Court: the July term 1875, thereof, and being the  
day appointed by said Court for the hearing of said applica-  
tion, appears said Caroline Jenkins and makes applica-  
tion to become a sole trader in pursuance of the Act of  
the Legislature of the State of Nevada entitled "An Act to  
authorize married women to transact business in their own  
names as sole traders, Approved February 6th 1867." And it  
appearing to this Court that said Caroline Jenkins has  
published the notice prescribed by law; a copy of which  
notice with affidavit of Publication is now on file in  
this Court. And the Court having examined the applicant  
fully on oath as to the reasons which induce her to make  
said application and it appearing to this Court that  
a proper case exists therefor, and that said Caroline Jenkins  
is entitled to an order permitting her to carry on business  
in her own name, and on her own account and the oath  
prescribed by Statute having been administered to said appli-  
cant, prior to making the order, a copy of which oath is  
heron endorsed, and no objection to said application  
having been made. It is therefore ordered that the said  
applicant Caroline Jenkins, be, and she is hereby authorized  
and empowered to carry on in her own name and on her  
account the business of keeping a boarding and lodging  
house, and furnished and unfurnished rooms & saloon business  
& buying and selling and dealing in real and personal property.
