Sterling Mining Company.

Know all Men by these Presents. That we the undersigned, have this day associated ourselves together, for the purpose of incorporating under the Laws of the State of California, a Corporation to be known by the corporate name of the Sterling Mining Company.

And we hereby certify that the objects for which this Corporation is formed are:

To mine for and to work mines of Gold and Silver and other metals in Eureka District, Eureka County, State of Nevada, and to do all things necessary and usual to be done in and about developing and working such mines and working the ores thereof.

That the Capital Stock of this Company shall be Five Million Dollars (\$5,000,000) divided into Fifty thousand (50,000) Shares, of the par value of One Hundred Dollars (\$100) each,

That the time of its Existence shall be Fifty (50) years from and after the date of these Articles.

That the Number of its Trustees shall be Five (5) and that the names of those who shall be Trustees and manage its affairs during the first Three Months and until their successors are elected are Adam Hall and William Arrington both of Eureka, Eureka Co., Nevada George F Bragg, John Chamberlain, and Stephen Roberts of San Francisco, San Francisco Co., California.

That the Principal place of business shall be in the City and County of San Francisco, California.
