And now upon this 18th day of December A D 1875, being a day of the regular of said Court to wit: The November term 1875 thereof and being the day appointed by said Court for the hearing of said Application, appears said Harriet A Bailey and makes application to become a Sole Trader in pursuance of an Act of Legislature of the State of Nevada, entitled "an Act to authorize married women, to transact business in their own names as sole traders," Approved Feb'y 6<sup>th</sup> 1867. And it appearing to this Court that the said Harriet A Bailey has published the notice prescribed by law, a copy of which notice with affidavit of publication is now on file in this Court and the Court having examined the applicant fully on oath as to the reasons which induce her to make such application and it appearing to this Court that a proper case exists therefore & that said Harriet A Bailey is entitled to an order permitting her to carry on business in her own name & on her own account and the oath prescribed by statute having been duly administered to said applicant prior to the making of the order, a copy of which oath is herein endorsed and no opposition to said applicant having been made. It is therefore ordered that said applicant Harriet A Bailey be, and she is hereby authorized and empowered to carry on in her own name and on her own account the business of keeping a lodging house buying and selling and dealing in real estate and personal property Eureka Dec 18th 1875.
