Geo. K. McCulloch

being first duly sworn deposes and says: That he is now the owner of Five Hundred (500) feet of the ledge or lode of which a copy of the original notice of location is hereto annexed, marked exhibit "A". That this deponent derived his title to said interest in said mine as follows to wit:

That on the 19th day of January 1870 Adam Hall, D. Satterly and Peter Sights conveyed by Deed to G. W. Allen an undivided six hundred (600) feet of said Bully Boy lode.

That on the 29th day of November A.D. 1871 said G. W. Allen, conveyed by deed to said George K. McCulloch, this deponent, and one Frank C. Swift an undivided six hundred (600) feet of said Bully Boy lode. Both of which said deeds are duly recorded in the records of Esmeralda County, State of Nevada. That thereafter said deponent duly acquired a further interest in said Bully Boy ledge, lode, or mine by deeds duly recorded from said J. W. Allen & his grantees whereby said deponent became and is now as aforesaid the owner of an undivided five hundred (500) feet of said Bully Boy ledge lode or mine.

Deponent further says that in pursuance of the Act of Congress approved May 10<sup>th</sup> 1872 and the several acts amendatory and supplementary thereto he, this deponent has done work and labor on said mine required and necessary to be done up to and prior to 16th day of November A.D. 1875 at his own expense and charge and that said Frank Swift has neglected and refused to pay his proportion of said necessary work labor and expenditures required by said Act.

That in pursuance of said Act this deponent caused to be published in the Esmeralda Daily Sentinel a newspaper published in said County and State a notice of which Exhibit "B" hereto attached is a copy and which together with the affidavit hereto attached is made a part of this affidavit and to which reference is hereby specially made.

That further in pursuance of said Act and of said notice published as aforesaid this deponent hereby gives notice to said Frank Swift to whom it may concern now or hereafter in any way or manner that he is now the owner of all the interest of the said Frank Swift which said Swift owned at the date of the publication of said notice or at any time thereafter.

To Frank Swift his heirs administrators or assigns. You are hereby notified that I the undersigned, your co-worker, have performed work and labor on the "Bully Boy" mine or lode, situated near the head of New York Canyon, in Eureka Mining District Eureka County Nevada, under the provisions of an act of Congress entitled "an Act to promote the development of the mining resources of the United States" approved May 10<sup>th</sup> 1873 and the several acts amendatory and supplementary thereto to the amount rendered necessary by said act and that you have failed to perform your proportion of such work according to your interest in said mine or have the same done. And that unless you pay to the undersigned your just proportion of the expenditure of said work according to your interest in said mine within 90 days after the publication of this notice that your interest in said mine will become the property of the undersigned under and by virtue of the said Act of Congress.

That the interests owned in said mine are as follows:

Frank Swift 300 feet G K McCulloch 500 feet in all Eight hundred feet.
