 entitled action tested the 8th day of August A.D. 1872 by which  
 I was commanded to make the amount of three hundred  
 Dollars (\$300) gold coin of the United States, to satisfy the  
 judgment in said action with costs taxed in the sum of  
 Sixty and 50/100 Dollars and interest out of the personal prop-  
 erty - of Thomas Nulty the defendant in said action and if  
 sufficient personal property could not be found, then out  
 of the real property belonging to said defendant Thomas Nulty  
 on the 5th day of August A.D. 1872 or at any time thereafter  
 as by said writ, reference thereto being had, more fully ap-  
 pears I have levered upon and this day sold at public  
 auction according to the statute in such cases made and  
 provided to Charles Goll who was the highest bidder for  
 the sum of One Hundred Forty seven and 50/100 Dollars gold  
 coin of the United States, which was the whole price  
 paid by him for the same the real estate particularly des-  
 igned as follows to wit that certain piece or parcel of land  
 or woodranch situated in Lander County State of Nevada  
 about eight miles northeast from Eureka in said County  
 and State and being upon the north branch of Hooper Canon and  
 known as the Old Nulty ranch. that the said real estate is  
 subject to redemption in gold coin of the United States pur-  
 suant to the statute in such cases made and provided  
 Given under my hand this 29th day of August A.D. 1872
