## Release of Agreement.

Know all men by these presents: that whereas on the 16th day of May AD 1876 a certain agreement was made and entered into between Balthas Volk and Martino Prantoni of the one part and G Leclier Robbing of the other part whereby the said Volk and Prantoni agreed to sell and the said Robbing agreed to purchase within the period of thirty (30) days from said 16th day of May AD 1876 for the sum of sixty thousand, (60,000 Dollars in U.S. Gold coin) the following mining grounds to wit: Seven hundred and seventy five (775) feet of the Washington ledge or lode; One thousand (1000) feet of the Washington Grand, ledge or lode, Seven hundred and fifty (750) feet of the Matamoros ledge or lode; Six hundred (600) feet of the Santa Godardo ledge or lode; Six hundred (600) feet of the "Lelyde" ledge or lode also seventy nine and  $\frac{56}{100}$  ( $79\frac{56}{100}$ ) acres of wood land with tenements etc all of which mining property and real estate is situated on the Western slope of Prospect Mountain in the Eureka Mining District, Eureka County State of Nevada, which agreement is duly recorded in Book "A" of Miscellaneous page 312 of the Records of Eureka County aforesaid in the Recorder's Office of said County, and whereas it is the mutual desire of said Volk, Prantoni and Robbing to cancel and annul said agreement and respectively to relieve themselves from any and all obligations, each to the other under the said agreement

Now therefore it is hereby declared by the said Balthas Volk and Martino Prantoni and said G Leclier Robbing in consideration of our said mutual desire that the said agreement herebefore recited is hereby cancelled and abandoned and all and every obligations and liability under the same each to the other is hereby released cancelled abandoned and rendered void and of no effect
