executors or assigns as hereinafter stipulated for which pay-
ment well and truly to be made we bind ourselves jointly
and severally and our heirs executors and administrators
and each of them.

The above mentioned three thousand Dollars is to become
due and be collectible whenever we the said A Benedict
A E Titus, R P Mc Danell and Sam'l Cooper or our heirs
executors or administrators or any of them or us consummate

a sale of the property known and designated as the Bald Eagle Mine.
