On this, the first day of May, A.D. 1876, in consideration of the sum of Fifteen hundred and fifty (\$1550.⁰⁰) Dollars, gold coin of the U.S., to me in hand paid by D W Levan, of Eureka County, State of Nevada, the receipt whereof is hereby acknowledged at and before the enrolling and delivery of this - I do hereby grant bargain and sell and convey unto said D W Levan the following described personal property now in my possession situated in the Eldorado Saloon Building on Lot (11) Eleven in Block (No 5) five in the Murray Survey town of Eureka, and particularly described as follows to wit: Two (2) cases Swan's Ale One (1) Case Tennants Ale, Six (6) doz Bot. Ale, four (4) qts Hedsick Champagne, Eighteen (18) pints Cal Champagne, Ten (10) gal Stag C D Whiskey. Twenty two (22) gal Holland gin, four (4) bot Vermuth biters, Twelve (12) gal sherry wine, ten (10) gal brandy, five (5) gal Irish whiskey One (1) crate Sellers water (broken) One (1) case gum syrup, fifteen (15) gal Jamaica rum, eight (8) bot Hostetters Bitters twenty two bot J & S Bitters four (4) Bot peppermint, nine (9) jugs Curaca bitters; five (5) gal scotch whiskey, four hundred (400) cigars; Eighteen (18) Bot Claret, four (4) bot Orange biters eight (8) bot Augustora Bitters; four (4) bottles Benedictine; thirty (30) bot Porter, five (5) bot Cassis, four (4) doz bar and Lemonade glasses, Six (6) Bitter bottles, Two (2) silver plated lamps, forty (40) lamps with hangings and chandeliers; Two (2) silver plated fruit stands, One (1) spirit lamp, Two (2) lemon squeezers, sixty (60) chairs One (1) Faro table and six (6) stools, Two (2) card tables, Two (2) bells. Five (5) vases, Thirty six (36) bar bottles with contents
