The application of Matilda A Ashim wife of Simon Ashim coming on regularly to be heard the 10th day of March A D 1857, at the regular March Term A D 1857 of said Court and proof having been first made to the satisfaction of the Court that notice in due form and substance of petitioners intention to make this application had been duly published in the Eureka Daily Sentinel, a newspaper published and circulated in the town and County of Eureka, State of Nevada, for four (4) successive weeks the Court proceede to hear the said application and said applicant appearing in person in open Court and having been duly examined by said Court under oath as required by law and after hearing said applicants proof; it duly appearing to the satisfaction of the Court that a proper case exists for granting the order and that said applicant is and has been a resident of the County of Eureka aforesaid for six months and upwards, next preceding her application herein Thereupon said applicant did make and file with the Clerk of this Court the oath required by law and the Court now here finds the following facts from the proofs and in accordance.

1. That the application is made in good faith to enable said applicant to support herself and her children, that said application is not made with any view to defraud, delay or hinder any creditor or creditors of the husband of said applicant and that of the moneys so to be used in the business of said applicant not more than five hundred dollars has come either directly or indirectly from the husband of said applicant. Now Therefore by virtue of the law and the premises it is ordered, adjudged and decreed that she the said Matilda A Ashim, be and is hereby authorized and empowered to carry on in her own name and on her own account as a sole the business specified in said notice as follows to wit: That of buying and selling real estate, goods wares and merchandise.
