Know all men by these Presents, That, D. B. Inman of the Town and County of Curwena State of Nevada for and in consideration of the sum of Five (5) Dollars Gold Coin of the United States, and the further consideration of the Trusts hereinafter set forth,

do by these presents, sell, transfer, convey, assigns and set over unto W. R. Chamberlain, H. Bishop and W. B. Bartlett each and all of the said Town of Curwena, the following described Real and Personal property, situated being and being in the Town and County of Curwena, State of Nevada, to-wit; First- All my right title and interest in and to Lot number Three (3) Block Five (5) Mason's Survey of the said Town of Curwena, as also Lots one (1) Two (2) and Three (3) Block number forty (40) W. C. Boy's Survey of said town of Curwena together with all the improvements thereon situated and thereunto belonging. Second All Personal property, safe contents and fixtures in the Banking House of D. B. Inman & Co in said Town of Curwena, together with all and singular the debts, dues and demands of the said D. B. Inman or D. B. Inman & Co now due or to become due to them or either of them - constituting all and singular all the assets of whatever nature or kind belonging to said D. B. Inman and to or said D. B. Inman & Co in virtue of them, The intention hereby being to sell, assign, transfer, convey, and set over to the said W. R. Chamberlain, H. Bishop and W. B. Bartlett, all the assets of the said D. B. Inman or D. B. Inman & Co now due and all of them, of every nature, kind and description whatsoever - for the purposes as hereinafter stated - To have and to hold to the said W. R. Chamberlain, H. Bishop and W. B. Bartlett their heirs and assigns in trust nevertheless - for the following uses and purposes - to-wit

Whereas, I have been engaged in the Banking business at the Town and County aforesaid, under the name of D. B. Inman & Co and am indebted to sundry and divers parties in said Town and County of Curwena including the Trustees herein named in large sums of money aggregating the sum of Twenty eight Thousand (28,000) Dollars more or less and whereas it is my desire to secure all of my said creditors, residing in said County who shall

come in, and by writing accept the benefits of this Assignment  
 Now therefore this Indenture is made and the said M. R. Chamberlain  
 H. Bishop and M. B. Bartlett are fully authorized and empowered  
 to enter into and take possession of all my said property both  
 real and personal, to hold the same for the purposes herein expressed.  
 The said M. R. Chamberlain, H. Bishop, and M. B. Bartlett or any two of  
 them are fully empowered to sell and dispose, grant, bargain  
 and convey, any and all of said property in such manner  
 and on such terms as they or any two of them may deem  
 best, to collect all debts due or demands owing to me or said  
 D. B. Inman & Co, and out of the proceeds thereof to pay pro rata  
 all to whom I may be indebted who may come in and accept  
 under this trust, who reside in said County of Eureka including  
 themselves that is as follows: to wit - The said Trustees shall first  
 pay all the expense of executing this Trust and the balance  
 distributed as above stated.
