

B. Rothchild This agreement made and entered into in  
 with the State of Eureka County of Nevada State  
 A. D. Haskell of Nevada the 19<sup>th</sup> day of December A.D. 1877  
 Between B. Rothchild and A. D. Haskell of  
 Eureka, Eureka County State of Nevada. Witnesseth. That  
 the said B. Rothchild having this day conveyed to the  
 said A. D. Haskell and undivided half interest in the  
 following described mining property situated in said  
 County of Eureka State of Nevada to wit, an undivided  
 half interest in the Fanny Lode or mine said lode con-  
 taining eight hundred (800) feet and recorded in Book  
 D. and page (200) in the Eureka District Mining Records;  
 in the Ida mine or lode, said mine containing eight hundred  
 (800) feet Recorded in Book "D", page (354) Eureka District  
 Mining Records, in the Charlotte mine or lode said mine  
 containing eight hundred (800) feet Recorded in Book "D"  
 Page (355) Eureka District Mining Records, And the said  
 A. D. Haskell having this day conveyed to the said B.  
 Rothchild an undivided half interest in the following  
 described lode or mine, situated in said County and  
 State to wit, in the Franklin Scott Lode or mine said  
 mine containing, six hundred (600) feet and Recorded  
 in Book "A" at Page (186) Eureka District Mining Records  
 all of the aforesaid mining property being located on the  
 Eastern Slope of Prospect Mountain in the Eureka  
 Mining District. The said B. Rothchild and the said  
 A. D. Haskell have become and now are the owners of the  
 said mining property, each being the owner of an undivided  
 half interest of the same as heretofore in common and they  
 have agreed upon the following terms and articles of  
 agreement of association for the possession and working  
 said property. The said parties agree to consolidate all  
 of their said interests in said mines for the purpose of  
 working the same, and that the said mining property  
 shall be known as the Ida and Franklin Scott consolidation  
 and it is agreed by and between the said parties that the  
 said mines shall be worked to the best advantage and for  
 the best advantage, and for the interest of the owners herein  
 under the supervision and management of some experienced  
 mining Superintendent or Foreman who may be selected by the  
 parties hereto, and that the expenses for working the  
 same shall be equally borne by the owners herein, and it  
 is further agreed that either party to this agreement  
 may if he so desire, sell, assign or dispose of his whole  
 or any part of his said interest in said consolidation of  
 mining property by giving ten days notice to the other party  
 and that in the event that either party should have an op-  
 portunitiy of selling or disposing of his interest in said  
 property, he shall give his co-owner the preference of purchase  
 before making said sale provided an equal amount is  
 given by said co-owner for the interest so offered for sale  
 And it is further agreed that should it appear to the be-

intended of the parties hereto that an incorporation  
of the above mining property should be formed either under  
the laws of the State of Nevada or California) for the purpose  
of working said mine and disposing of the stock of said  
incorporation, then and incorporation Company shall be  
formed & perfected, the number of shares to issue, manag-  
ement of the same &c to be hereafter agreed upon by the parties
