Order of Sale

Application having been made to this Court by
the petition in writing of Hiram Johnson, the
Executor of the last will and testament of Dominick
B. Scherlock deceased, heretofore filed in the Court

to wit; on the 19th day of December A.D. 1877 for an order to sell either at public or private sale or both public or private sale as might to the said Executor seem best for the interest of said Estate the whole of the personal and real property belonging to said Estate, which petition fully set forth the matters enumerated and required in the statute in such case made and provided and which said petition was verified by the oath of the said Executor, and an order having been made thereupon directing all persons interested in the Estate to appear before this Court at a time and place specified, to wit; on the 19th day of January A.D. 1878 at the hour of 10 o'clock A.M. at the Court Room in the Town of Eureka in said County to show cause why an order should not be granted to the said Executor to sell the whole of said real and personal property belonging to said estate either at public or private sale or both as he might deem for the best interest of said estate, and ordering that a copy of such order be published at least four successive weeks in the "Eureka Daily Republican" a newspaper published in the said Town of Eureka County and State aforesaid; Now at this time and at the place appointed in such order upon satisfactory proof of the due publication of a copy of the order by affidavit, this Court proceeded to the hearing of such petition, and heard and examined the allegations and proofs of the Petitioner no persons interested in the estate opposing the application, and the court being satisfied after a full hearing upon the petition and an examination of the proofs and allegations of the parties interested that a sale of the whole of the personal and real property belonging to said estate is necessary for the payment of the debts outstanding against the deceased and the debts, expenses and charges of the administration for such purpose, and William H. Lavenholt Esq. who was heretofore appointed by this Court, attorney to represent the minor and absent heirs and devisees of said decedent, consenting to this order and it further appearing that all the proceedings upon this application have been conducted strictly according to law, or motion of Lansing & Bailey counsel for said Executor; It is hereby ordered, adjudged and decreed that said Thiram Johnson Executor for the last will and Testament of Dominick C Scherlock deceased. be and he is hereby authorized and empowered to sell of the real and personal property belonging to said Estate at public or private sale or at either public or private sale as he may deem for the best interest of said estate for cash. The following is the real estate hereby authorized to be sold being situated in the Town and County of Eureka and state of Nevada aforesaid to wit; Lot Number Four (4) in Block Number Eight (8) in the A. Monroe Survey of said town of Eureka with the improvements thereon appraised at the sum of \$8000 Dated at Eureka, Eureka County State of Nevada on this 19th day of January A.D. 1878
