Agreement

This Agreement made and entered into this 8<sup>th</sup> day of June 1878  
by and between Max Oberfelder of the Town and County of  
Eureka State of Nevada the party of the first part and  
William T. Davis of the same place the party of the second part Witnesseth

That the said party of the first part for and in consideration of the covenants and agreements hereinafter contained and stipulated to be performed on behalf of the said party of the second part, does hereby covenant and agree to and with the said party of the second part, to sell and convey unto the said party of the second part, those certain lots, pieces and parcels of land known and described as lots Number ten (10) eleven (11) and twelve (12) in Block number fourteen (14) of the Edwards Survey of the Town, County and State aforesaid for the full sum of eleven hundred (\$1,100) Dollars in United States Gold Coin to be paid as hereinafter stipulated on the part of the party of the second part. And the said party of the second part for and in consideration of the premises and of the covenants and agreements hereinbefore stipulated on behalf of the party of the first part does hereby covenant and agree to and with the said party of the first, to buy the said property and premises hereinabove described for the said sum of Eleven hundred Dollars in U.S. Gold Coin to be paid as follows the sum of One hundred and fifty (\$150<sup>00</sup>) in U.S. Gold Coin on the 1<sup>st</sup> day of July 1878 and the balance in equal monthly payments of fifty (\$50) Dollars each to be paid on the first day of each and every month after the said first day of July 1878. It is understood and agreed by and between the parties hereto, that the said party of the second part shall be entitled to the possession of the premises above described, during the pendency of this agreement. It is further agreed that the said party of the second part shall pay interest upon the deferred payments of fifty dollars per month on all such payments after the first at the rate of one per cent per month.
