In the matter of the application of Mrs Georgia Compton for permission to transact business in her own name and upon her own account as a Sole Trader

This application came on to be heard in open Court on the 20th day of June A.D. 1878 and from the testimony offered by the applicant the Court finds the following facts That due notice of said application was published for

four consecutive weeks, commencing on the 4th day of May, and ending on the 25th day of May A.D. 1878 in the "White Pine News" a public news-paper printed and published at Hamilton in said County, That said Georgia Compton is a married woman, and the wife of John Compton a resident of White Pine County and State aforesaid, That for some time past the said John Compton has not contributed to the support of the said Georgia Compton and her child, That said applicant is a resident of White Pine County Nevada, and that it is her intention to engage in the business of stock raising; also buying and selling and dealing in real and personal estate in the County and

State aforesaid in her own name and on her own account and that she is dependent upon her own exertions for her maintainance and support of her child, And the said applicant having taken the oath prescribed by law, Now therefore it is ordered that said applicant be authorized and empowered to carry on business in her own name and on her own account, viz; to engage in Stock raising, also in buying and selling and dealing in real and personal estate under and by virtue of the provisions of an act of the Legislature of the State of Nevada entitled an Act to authorize married women to transact business in their own names as Sole Traders" approved Feby 6th A.
