


V Inventory of Missouri A. White | Know all men by these presents that I Missouri
 Missouri A. White | A. White wife of Thomas J. White of the Town &
 County of Eureka and State of Nevada am the
 owner by purchase from W. A. Seaton and wife of the land and
 premises herein described; to wit; That certain piece and parcel
 of land situate lying and being in the Town and County
 of Eureka and State of Nevada and being lots Number Seven
 (7) and Eight (8) of Block Number Five (5) of the Mc Coy survey
 of said Town together with the tenements hereditaments and
 appurtenances thereunto belonging or in anywise appertaining
 That I purchased said premises with money my own separate
 property and belonging to me prior to Marriage. That I also
 own and am possessed of certain other personal property situated
 in the Lodging house erected on lot Number Six (6) in Block
 Five (5) of said Mc Coy Survey, to wit; An undivided one half (1/2)
 of all the household and kitchen furniture in said lodging house.
 The same consisting of Twelve (12) Beds & Bedsteads 12 carpets
 Twelve (12) tables and chairs, pillows, ^{the} blankets, coverlids & pillows
 now belonging to said beds and all small stoves and the kitchen
 stove and furniture together with all crockery Glassware and cutlery
 now in said lodging house That the above personal property
 was purchased by me with money earned by me separate and
 apart from my husband and with money earned by me and
 appropriated by me to my own use by the allowance and consent
 of my said husband and with money owned by me prior to Marriage
 That I further own two bay mares branded "W" on the left thigh
 the same having been a gift to me from H. Brisacher Now therefore
 I the said Missouri A. White wife of the said Thos. J. White by and
 with the consent of my said husband signified by his signing
 and executing these presents do hereby publish make known
