Moody and the proofs of the facts alleged therein having been duly submitted to and heard by the Court, and the Court having <sup>filed</sup> its findings of fact and conclusions of law thereon, from which it appears that Plaintiff is entitled to the relief prayed for in the complaint, and it also appearing that said Defendant was duly served with process, and the Court being fully advised in the premises, it is hereby Ordered, Adjudged And Decreed, That the marriage between the Plaintiff Emily Anderson and the Defendant John Anderson be dissolved, and the said parties are, and each of them is freed, and absolutely released from the bonds of Matrimony, and all the obligations thereof, and that the sole care, control, custody and charge of the four minor children issue of the marriage of Plaintiff and Defendant, viz: Lucy, Comfort, John and Emily be and the same is hereby awarded to the said Plaintiff Emily Anderson. And that following described property real and personal be and the same is hereby declared to be her own separate and individual property and estate to wit; those certain parcels of land known as and called Lot number four and five in Block C of the Monroe Survey of the Town of Esmeralda in the County of Esmeralda, State of Nevada, and the building lying thereon, and the household furniture in said building and have her costs of suit from Defendant taxed at \$41.00.
