Agreement

This agreement made and entered into this ninth day of February A. D. 1880, in the Town of Eureka, State of Nevada, by and between D. J. J. MacLaughlin, W. H. Burns, Thomas Brown and Myles Hogan, all of Eureka County, State of Nevada. It is hereby understood and agreed between the parties hereto, that they, this day consolidate certain mining interest, belonging to each of the parties hereto respectively, hereafter described; That the said D. J. J. MacLaughlin is the owner of Seven Hundred (750) and fifty feet of mining ground on the Crown No 2 & the Nevada and Hope mine or Lode. That the said W. H. Burns, Thomas Brown, and Myles Hogan are the owners of Seven Hundred and fifty (750) feet of said mining ground on the said Crown No 2 Lode, and the Nevada & Hope Mine or Lode, the said Burns, Brown and Hogan, being the owners of, & entitled to, one Sixth interest each, or (250) lineal feet each in the said Mine or Lode. The said Crown No 2 Lode, and the Nevada and Hope mine being located on the same Lode or Deposit all of the said Mining property being situated and located on Mineral Hill, in Eureka Mining District, Eureka County Nevada. And it is hereby agreed between all of the parties hereto, that the said mining ground, to wit: the Crown No 2 the Nevada and Hope Mine or Lode, consisting in all of Fifteen Hundred lineal (1500) feet, be and all the interests in the same are hereby consolidated. That said Consolidation shall be known by the name of the "Hope Consolidated Lode", and that each of the parties hereto shall hold and own their respective interests above described under said Consolidation.
