

## Chattel Mortgage

Frank Money  
To  
A. R. Wright

This indenture made the 26th day of February 1880  
between Frank Money of Eureka party of the first  
part and A. R. Wright of Ruby Valley Elko County  
the party of the second part, Witnesseth that said  
party of the first part for and in consideration of the sum of Eleven  
Thousand Three Hundred and Nineteen Dollars to him in hand paid  
by said party of the second part the receipt whereof is hereby acknowledged  
both bargained sold assigned transferred and set over and by these  
presents doth bargain sell assign transfer and set over unto the said  
party of the second part the following described property to wit. All of the  
cattle of said party of the first part now running on the range in the  
Counties of Elko, White Pine and Eureka in the State of Nevada brand-  
ed with the following brands  $\Delta$ . 71. 71  $\cup$ . 111. also an undivided one  
half interest of said party of the first part in and to all cattle run-  
ning on the range in said Counties branded as follows  $\cup$ K. Also all  
of the horses of said party of the first part running on the range in said  
Counties except ten to be selected by said party of the first part. To have  
and to hold all and singular the said cattle and horses above bargained  
and sold or intended to be unto said party of the second part his heirs,  
executors administrators and assigns forever. Provided nevertheless and  
this indenture is upon this express condition that if said Frank Money the  
party of the first part his heirs, executors, administrators or assigns shall  
well and truly pay unto A. R. Wright the said party of the second part  
his heirs, executors administrators or assigns the promissory notes of which  
the following are copies on or before the 26th day of November 1880.

One day after date I promise to pay W. S. Griswold or order the sum of Fifteen Hundred Dollars (\$1500.<sup>00</sup>) value received interest at the rate of two per cent 2% per month from date until paid

\$ 3000.<sup>00</sup>Ruby Valley Nev. Dec. 16<sup>th</sup> 1879

One day after date I promise to pay J. H. Taber or order the sum of Three Thousand Dollars for value received with interest at the rate of one and one half percent per month from date until paid.

\$ 1621.<sup>00</sup>Eureka May 5<sup>th</sup> 1879

One day after date for value received I promise to pay to W. S. Griswold or order the sum of Sixteen Hundred and Twenty One Dollars (\$1621.<sup>00</sup>) interest at the rate of Two percent (2%) per month from date until paid

\$ 673.<sup>75</sup>Eureka Nev. Feb. 17<sup>th</sup> 1880

One day after date I promise to pay to J. T. Wright or order Six Hundred and Seventy Three Dollars and Fifteen cents in gold coin of the United States with interest at the rate of two percent on the dollar per month.

"Paid \$50.<sup>00</sup> Feby 21<sup>st</sup> 1880."\$ 2369.<sup>00</sup>Ruby Valley Sept 8<sup>th</sup> 1879

One day after date without grace I promise to pay to the order of A. R. Wright the sum of Two Thousand Three Hundred and Sixty Nine Dollars for value received with interest at two percent per month from date until paid both principal and interest payable only in United States Gold coin

On demand without grace I promise to pay to Hamell & Meigs or order the sum of One Hundred and Thirteen <sup>69</sup>/<sub>100</sub> Dollars payable only in gold coin of the Government of the United States for value received with interest thereon, in like gold coin at the rate of two percent per month from date until paid

\$ 74.<sup>00</sup>Wells Nev. Apr. 23<sup>rd</sup> 1879



On demand without grace I promise to pay to Hamell & Meigs or order the sum of Seventy Four <sup>00</sup>/<sub>100</sub> Dollars payable only in gold coin of the Government of the United States for value received with interest thereon in like gold coin at the rate of two percent per month from July 1<sup>st</sup> 1879 until paid

(Endorsed "Hamell &amp; Meigs")

and interest on said notes according to their tenor and effect, and shall also pay the cost and charges of said party of the second part

For taking care of said cattle and horses it being understood and agreed between said parties of the first and second part that no more men than are strictly necessary shall be employed to take care of said cattle and the rate charged per month for each man required to take care of said cattle shall not exceed \$50.<sup>00</sup> and board, then this conveyance shall be void and of no effect, otherwise to remain in full force and virtue. And it is further stipulated and agreed by said parties of the first and second part that said party of the second part from time to time from the 26<sup>th</sup> day of February to the 26<sup>th</sup> day of November 1880 will deliver to said party of the first part upon his request a number of cattle not to exceed fifty head at any one time, either for sale or foot or for killing; said party of the first part to pay therefor to said party of the second part the market price per head to be applied towards the payment of said notes. In Witness Whereof said parties have hereunto set their hands and seals the day and year first above written.
