Miners Meeting

At a Miners meeting held this Fifth day of March 1880, in Richmond District, State of Nevada The following Rules and Regulations governing mining locations in said district were adopted. First - Richmond Mining District shall comprise an area of One Hundred and forty four square miles with the Echo mine as the central point. The North and South boundaries running East and West, and the East & West boundaries running North & South. Richmond Mining District is situated about fifteen miles northwesterly from Carlin station on the line of the Central Pacific P.R. and to the best of our knowledge is principally in Eureka County, State of Nevada. Second - Each and every location made within the boundaries of Richmond District shall be Recorded with the district Recorder within Twenty days, from the date of location. - Third - Each and every mining location made within the boundaries of Richmond District shall have expended in labor upon the same within Twenty days, from the date of location, the sum of, not less, than Twenty dollars. - Fourth - Upon application to the Recorder of any person or persons, to Record Mining ground, or for labor performed, the District Recorder shall examine the ground claimed, or labor performed, either personally or by deputy and upon the payment by the applicant to the Recorder, the Recording fees, The Recorder will place a description of the location made or labor performed, upon the District Record Book, and issue a certificate of location or of labor performed to the party or parties making the location or having performed the labor. Fifth - The Recorders fees for each location made and Recorded within a distance of two miles from the Echo Mine shall be Two dollars and a half, and for a greater distance, one dollar additional for each additional mile or fraction thereof. Sixth - Where application is made at one and the same time for a Record of location and Record of labor performed for the same Mine, the Recorders fees shall be Two Dollars and a half for both transactions, but when application is made at different intervals for Record of location and Record of labor performed, the Recorders fees shall be Two dollars and a half for either transaction. - Seventh - It shall be the duty of the Recorder upon the petition of at least five persons, citizens and owners, in five different locations in the district to call a meeting of the miners of the district by posting notices in three conspicuous places, and by publishing the call in one paper in Elko, County but under no consideration shall such a meeting be called without at least fifteen days notice. - Eighth - The Recorder of the District shall hold office for one year from the date of his election, or until his successor is elected. All Rules and Regulations in conflict with the foregoing, adopted here today are hereby Repealed. These Rules Regulations and proceedings shall be Recorded in the County Recorders office of Eureka County, State of Nevada Upon motion Mrs M Glidden was elected Chairman and C. H. Benson Secty of the above meeting C. P. Osgood was nominated for Recorder and unanimously elected. The foregoing Resolutions were adopted, Motion made and carried to adjourn.
