bind myself my heirs, executors and administrators, firmly by these
presents. Sealed with my Seal and dated the twenty eighth day of
June A. D. one thousand eight hundred and eighty

The condition of the above obligation is such, that if
the above bounden obligor shall on or before the first day of May A.
D. one thousand eight hundred and eighty one make, execute, and
delivers unto the said M L Bausey and R H Egleston or to their
assigns (provided that the said M L Bausey and R H Egleston
shall on or before that day have paid to the said obligor the sum of
One Thousand Five Hundred Dollars, gold coin of the United
States of America, the price by said M L Bausey and R H Egleston
agreed to be paid therefor), a good and sufficient deed for conveying
and assuring to the said M L Bausey and R H Egleston free
from all incumbrances, all my right, title and interest, estate claim
and demand, both in law and equity, as well in possession as in
expectancy, of, in or to that certain portion, claim and mining right,
title or property on that certain vein or lock of rock containing precious
metals of gold, silver and other minerals, and situated in the Secret

Caron Mining District, County of Eureka and State of Nevada and described as follows, to wit: Fifteen hundred feet of the Burning Moscow Ledge.


