This Indenture made the 23<sup>rd</sup> day of June 1896 between the Huntington and Diamond Valley Stock and Land Company, a corporation organized under the laws of the State of California, party of the first part Lessor, and Minnie C. Sadler of the City and County of San Francisco, State of California and Reinhold Sadler of Carson City, Ormsby County, State of Nevada, parties of the second part Lessees.

Witnesseth: That the said party of the first part hereby leases, conveys and lets unto the said parties of the second part, all its real and personal property, water and water rights

water ways and water ditches, situated, lying and being in the State of Nevada, and particularly in the Counties of Eureka, Elko and White Pine in said State, as particularly set forth and described in Exhibits "A" and "B" hereto attached and made part of these presents for the term of Six years, from the 23rd day of June 1896 to the 23rd day of June 1902, for the rental and consideration and upon the terms as follows: For the one half of the increase of the Cattle, Horses and live stock during said term, such increase to be ascertained and division made at the end of said term of six years, the said Lessees to have and be entitled to receive one half the net proceeds of all sales of beef Cattle made from the Cattle and stock now belonging to said Cattle upon the land and ranges of the Lessor for the years 1897, 1898, and 1899 and further that the Lessor will pay the cost and expense of breaking and clearing fifty acres of the said term land each year during said term and seeding the same to Alfalfa. Said Lessees to furnish the laborers, teams and farming implements for preparing and breaking said land and soil and sowing said seed, but at the cost of the Lessor and said Lessor specially agreeing to pay all taxes upon the real and personal property during said term also agreeing to pay, as the same becomes due and payable, interest on all contracts with the State of Nevada, for the purchase of any and all land hereby term under contract of purchase with the State of Nevada. Said Lessees hereby agreeing that they will during said term handle care for farm and manage said lands and personal property and every part thereof, to the best advantage and for the best interest of all parties concerned, and that they will at the expiration of said term return and surrender said Lands and personal property, except the portion of said personal property which they are hereunder entitled to retain, in good condition, reasonable use thereof excepted, to said Lessor its Agent or attorney
