Whereas, Reinhold Sadler, resident of the Town of Eureka, Eureka County, Nevada, did, on the 31st day of October, 1905, remise, release and quit-claim unto Alfred Street, resident of the same place certain real property situate in said town of Eureka which property is particularly described in said instrument in writing, to which reference is hereby made for a full and complete description thereof, and which instrument was recorded in Book of Deeds No 15 on Pages 125, 126, 127 and 128 of Eureka County Records on the 9th day of January, A.D. 1906, upon certain terms and conditions therein contained; and, whereas, the said Alfred Street and his wife, Mrs. A. Street did on the 8th day of January, A.D. 1906 sell, and transfer unto F. A. Carter Miller his remaining one third interest in the said instrument and property; and whereas, the said Alfred Street is desirous of purchasing the said property described in said first instrument herein described, and the said George C. Campbell and J. Carter Miller are willing to sell the same now Therefore we, George C. Campbell and J. Carter Miller do hereby, in consideration of one dollar to us in hand paid, sell and convey unto the said Alfred Street our and each of our title and interest in and to said property, and every part thereof, to have and to hold unto his heirs and assigns forever.
