Adjudged and Decreed, that the accounts of said Administrator be, and the same are hereby settled, allowed and approved, and that due and legal notice to the creditors of said estate has been given, and that the residue of said estate hereinafter particularly described, and any other property not now known or discovered, which may belong to the said estate, and in which the said estate may have any interest, be and the same is hereby distributed as follows:- One undivided one-twelfth interest in and to the patented mine known as and called the Delaware, one undivided one-sixth interest in and to the patented mine known as and called the San Jose, one undivided one-sixth interest in and to that certain unpatented mine known as and called the Summit, and one undivided one-sixth interest in and to that certain property known as and called the Orange Tunnel, to each of the following named heirs of said deceased, to-wit: Mrs. Gertrude Hager of Eureka, Eureka County, Nevada; Mrs. J. J. D'Arcy, Anna McGarry, Mrs. Ethel Agnew, nee Ethel McGarry, all of Superior, Wisconsin; Leonard P. McGarry, and William L. McGarry, both of Bullfrog, Nye County, Nevada. All of said mines and mining claims and said Orange Tunnel are situate, lying and being on Prospect Mountain, Eureka Mining District, Eureka County, Nevada.
