Zanolli Silver Copper Company Bill of Sale.

Know All Men By These Presents: That whereas, on the 12th day of December A. D. 1905, Gabriel Zanolli died testate in the County of White Pine, State of Nevada, being at the time of his death a resident of said County of White Pine, in said State, and leaving estate therein; and Whereas, Vincenzo Lani was named in the Last Will and Testament of said Gabriel Zanolli, deceased as the Executor hereof. And Whereas, the said Vincenzo Lani, did, on the 6th day of June A. D. 1906, duly qualify as the Executor of said estate, and letters testamentary in said estate signed by the Clerk, and under the seal of the Fourth Judicial District Court of the State of Nevada, in and for the County of White Pine, were duly issued to said Vincenzo Lani on said 6th day of June, A. D. 1906, and said letters testamentary in said estate have not been revoked, and said Vincenzo Lani is now the duly appointed, qualified and acting executor of said estate; And Whereas, there was included in the personal property left by said deceased Thirty-three Thousand Three Hundred Thirty-three (33,333) shares of the Capital Stock in the Zanolli Mining Company, a corporation organized and existing under and by virtue of the Laws of the State of Nevada, said shares of stock constituting a one-third interest in the Capital Stock of said Corporation; And Whereas, the said Zanolli Mining Company has now become defunct and the interest of all the stockholders therein, except the interest of Gabriel Zanolli, deceased, have since been disposed of to the Zanolli Silver-Copper Company, a corporation having one of its Principal places of business in Elko, Elko County, Nevada; And Whereas, Vincenzo Lani, the executor of said estate, believing that it was for the best interest of said estate to sell said 33,333 shares of stock in the Zanolli Mining Company belonging to said estate, did on the 10th day of January A. D. 1906 file with the County Clerk of White Pine County his petition praying for an order of sale of the personal property, to-wit, the 33,333 shares of stock belonging to said estate in said Zanolli Mining Company, to the Zanolli Silver-Copper Mining Company, at private sale, for the sum of Four Thousand Six Hundred Dollars (\$4,500); And Whereas, the Judge of said District Court did, on the 10th day of January A. D. 1906, and after the filing of the petition praying for the sale of the personal property of said estate, the 33,333 shares of stock in the Zanolli Mining Company, enter an

order whereby it was ordered that Monday, the 20th day of January A.D. 1908, at 10 o'clock A.M. of said day, at the court room of said court, at the court house in the City of Elko, County of Elko, State of Nevada, be set and appointed as the time and place for the hearing of said petition; and whereas, said petition duly came on for hearing on the 21st day of January, A.D. 1908, and after consideration hereof, the Judge of said District Court made and entered an order for the sale of the personal property of the estate of Gabriel Zanolli, deceased, and entered said order for the sale of personal property, it was ordered, adjudged and decreed that said Vincenzo Lani, as executor proceed forthwith to sell at private sale the following described personal property belonging to said estate, to-wit, Thirty-three Thousand Three Hundred Thirty-three shares of the Capital Stock of the Zanolli Mining Company, a corporation organized and existing under and by virtue of the laws of the State of Nevada, said shares constituting a one-third interest in the Capital Stock of said Company, to Zenoli Silver-Copper Company, a corporation having one of its principal places of business in the City of Elko, Elko County, Nevada for the sum and price of Four Thousand Five Hundred Dollars (\$4,500.), lawful money of the United States, the same being a reasonable and adequate price for said stock; And whereas, after said above order for the sale of said shares of stock had been duly made and entered by the Judge of said Court, the said Vincenzo Lani, executor of said estate, did, on the 22nd day of January, A.D. 1908, sell to the Zenoli Silver-Copper Company, a corporation having one of its principal places of business in Elko, County of Elko, State of Nevada, for the sum of Four thousand Five Hundred Dollars (\$4,500.), lawful money of the United States, the said 33,333 shares of the Capital Stock of the Zanolli Mining Company, the said stock belonging to the estate of Gabriel Zanolli, deceased; Now therefore, in consideration of the premises and the proceedings duly had and the orders duly made and entered by the Judge of the Fourth Judicial District Court of the State of Nevada, in and for the County of White Pine, I, the said Vincenzo Lani, the duly appointed, qualified and acting executor of the estate of Gabriel Zanolli, deceased, the party of

the first part for and in consideration of the sum
 of Four Thousand Five Hundred Dollars (\$4500.00),
 Gold Coin of the United States of America to
 me in hand paid by Zanoli Silver-Copper Company,
 a corporation duly organized and existing, under
 and by virtue of the Laws of the State of Utah, and
 having one of its principal places of business in
 Elko, Elko County, Nevada, the party of the second
 part, the receipt whereof is hereby acknowledged,
 do by these presents, grant, bargain, sell and convey
 unto the said party of the second part, its successors
 and assigns, 33, 333 shares of the Capital Stock
 of the Zanoli Mining Company, the said 33, 333 shares
 of stock belonging to and being the property of the estate
 of Gabriel Zanoli, deceased. It being the intention of
 the party of the first part, as the executor of said
 estate, to sell and convey, and he does as such
 executor hereby sell and convey unto the said
 party of the second part, all of the right, title, interest,
 claim and demand, both in law and in equity that
 the said estate of Gabriel Zanoli has or might there-
 after have in and to said 33, 333 shares of the Capital
 Stock of the Zanoli Mining Company To Have And To
 Hold the same, to the said party of the second
 part, its successors and assigns forever. And I do
 for said estate, and for the heirs, of said estate,
 covenant and agree to and with the said party
 of the second part, its successors and assigns, to
 warrant and defend the sale of said 33, 333 shares
 of the Capital Stock of said Zanoli Mining Company,
 and the said property, goods and chattels hereby
 made unto the said party of the second part, its successors
 and assigns, against all and every person and persons
 whomsoever lawfully claiming or to claim the same.
 In witness whereof, I have hereunto set my hand
 and seal as the executor of the estate of Gabriel
 Zanoli, deceased, after due authorization by the District
 Court of the Fourth Judicial District of the State of
 Nevada, in and for the County of White Pine, to
 make said sale, this 23rd day of January A. D. 1908.
