Mrs. Maggie Winzell, being duly sworn, says that she intends to occupy and hold not more than one hundred and sixty acres of public lands in Eureka County, State of Nevada, in accordance with the Act of the Legislature of the State of Nevada, approved March 9, 1865, entitled "An Act prescribing the mode of maintaining and defending possessory actions on public lands in this State"; the said lands being situated at what is known as and called "Cottonwood" about sixteen miles north-westerly from the J-D Ranch, and more particularly described as follows. Commencing at a post set in a mound of stone, marked "P.C.-A-08, Cor. No. 1"; from whence the corner to Townships 26 & 27 N., Ranges 49 & 50 East, bears S. 2° W., 521.00 chains distant; the spring at the head of Cottonwood, and about one mile above the corrals, bears S. 80° W., 60 links distant; and running thence:— 1st course, S. 82° 15' W., 33.00 cha., to a post set in a mound of stone, marked "P.C.-A-08, Cor. No. 2"; thence 2nd course, S. 19° 15' W., 71.00 cha., to a post set in a mound of stone, marked "P.C.-A-08, Cor. No. 3"; thence 3rd course, East, 15.00 cha., to a post set in a mound of stone, marked "P.C.-A-08, Cor. No. 4"; thence 4th course N. 30° 30' E. 82.00 cha., to post No. 1, the place of beginning. Containing 156.75 acres, more or less. That she has taken no other claim under this Act, and that to the best of her knowledge and belief, the said lands are not claimed under any existing title.

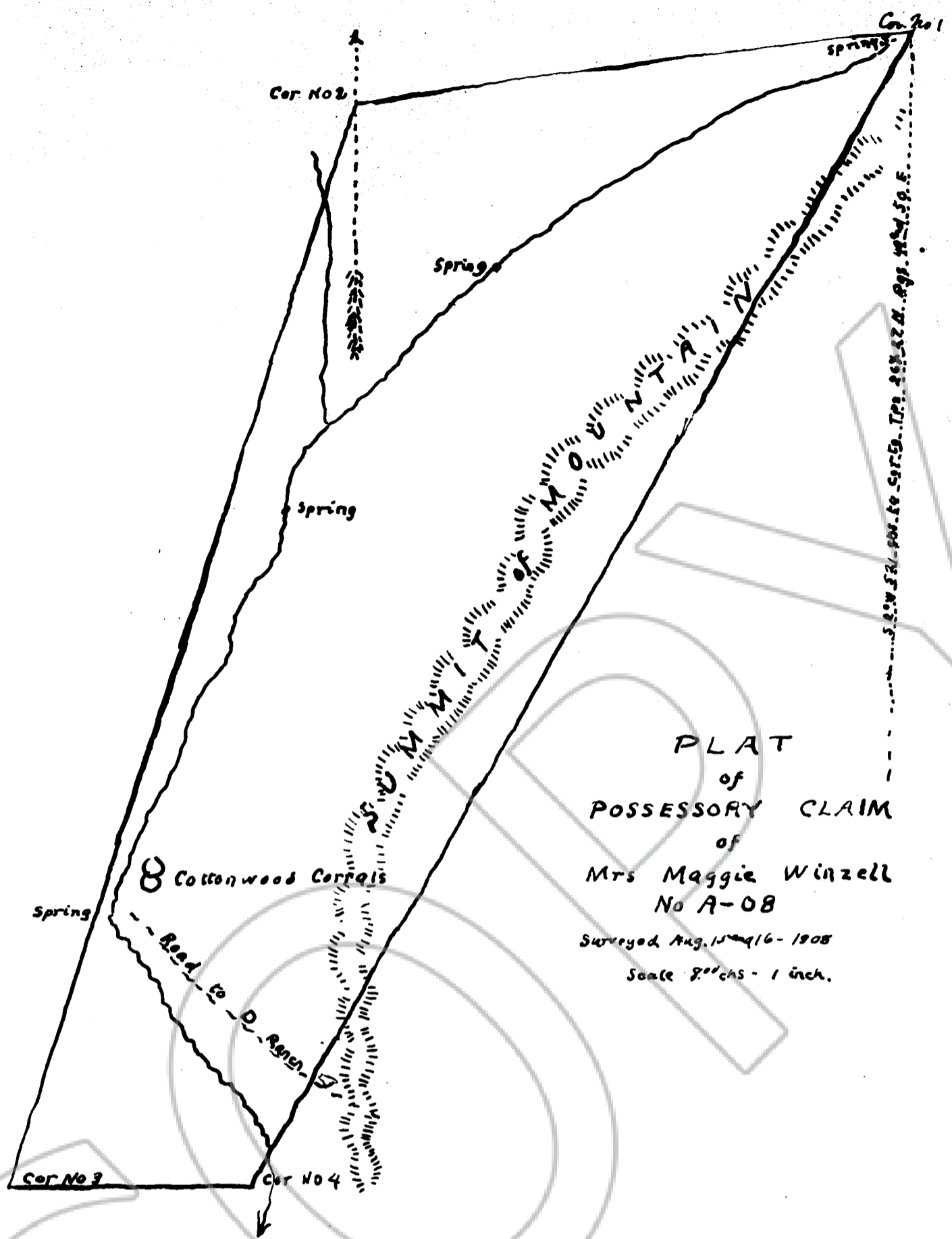
