

Release of Covenants.

This agreement, made this 10th day of June, 1909 by and between Edith M. Humphy of the City and County of San Francisco, State of California, the party of the first part, and James C. Humphy of the same place, the party of the second part.

Witnesseth:

That for and in consideration of the sum of Ten Dollars (\$10), Gold Coin of the United States of America, to her in hand paid by the party of the second part, the receipt of which is hereby acknowledged, the party of the first part hereby releases the party of the second

part from all of the obligations that may exist by virtue of that certain contract heretofore entered into by the parties hereto, dated the 19th day of September, 1904, and heretofore recorded as follows, in the office of the County Recorder of Contra Costa County, State of Nevada, on the 28th day of December, 1905 in Liber "C" of Miscellaneous records, at page 179; in the office of the County Recorder of Sander County, State of Nevada, on the 23rd day of December, 1905 in Liber 4 of Miscellaneous records, at page 426; in the office of the County Recorder of Elko County, State of Nevada, on the 16th day of January, 1906 in Liber 4 of Miscellaneous records, at page 577 and 578; in the office of the County Recorder of Monterey County, State of California, on the 8th day of February, 1906 in Liber "T" of Miscellaneous records, at page 120, and in the office of the County Recorder of the City and County of San Francisco, State of California, on the 21st day of February, 1906 in Liber 53 of Covenants, at page 99.

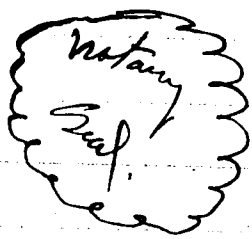
