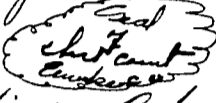

Mount Diablo Base and Meridian, containing one hundred and sixty (160) acres. Together with all water, water rights, dams, and

ditches, now or hereafter used upon or in connection with said premises. Together with all and singular the tenements hereditaments and appurtenances therunto belonging or in anywise appertaining and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

to have and to hold all and singular the said premises, together with the appurtenances unto the said party of the second part, and to his heirs and assigns forever.

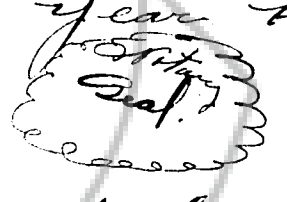
