THE UNITED STATES OF AMERICA.

TO ALL TO WHOM THESE PRESENTS SHALL COME, GREETING:

2.1864(13 Stat., 356), "to aid in the construction of a Railroad and Telegraph Line from the Missouri River to the Pacific Ocean and to secure to the Government the use of the same for Postal Military and other purposes, "and the Act of July 3, 1866(14 Stat., 79), authority is given to the Central Pacific Railrecd Company to construct a Railroad and Telegraph Line, under certain conditions and stipulations as expressed in said acts, and provision is made for granting to the said Company, "every alternate section of public land, designated by odd numbers, to the amount of ten alternate sections per mile on each side of said railroad on the line thereof and within the limits of twenty miles on each side of said road not sold reserved or otherwise disposed of by the United States and to which a pre-emption or homestead claim may not have attached at the time the line of said road is definitely fixed. "mineral land excluded; and WHEREAS, it is further provided in said Act of July 2,1864, that "the term 'mineral land' whenever the same occurs in this Act and the Act to which this is an amendment, shall not be construed to include coal and iron lands: " and WHEREAS, an official statement bearing date Bovember 3.1869 from the Secretary of the Interior. has been filed in the General Land Office showing that the line of said Railroad and Telegraph, from Ogden in the Territory of Utah to Sacramento City State of California has been constructed and fully completed and equipped in the manner prescribed by the Acts aforesaid; and Whereas it is shown by certain papers filed in the Department of the Interior and transmitted to the General Land Office by the Secretary of the Interior with his letter of December 27.1899. that the Centarl Pacific Railray Company by deed executed July 29,1899 has succeeded as grantee to all the property of the Central Pacific Railroad Company including the portions of the lands granted by the Acts of July 1,1862 (12 Stat., 489), and July 2,1864(13 Stat., 356), to aid in the construction of the Central Pacific Railroad and the Act of July 25,1866(14:Stat., 239), to aid

WHEREAS, by the Act of Congress approved July 1,1862(12 Stat.,489), as amended by the Act of July

in the construction of the California and Oregon Railroad, excepting, however, all the lands sold prior to the execution of the mortgage from the Central Pacific Railroad Company to Charles Crocker and Silas W. Sanderson, dated October 1,1870, and all such parts and parcels of said lands as shall have since been released from said mortgage in accordance with the provisions thereof; and

WHEREAS, certain tracts of land, not sold prior to the execution of the mortgage aforesaid and not since released therefrom, in accordance with its provision, have been listed under the acts land aforesaid by the duly authorized agent of said Central Pacific Railroad, now Central Pacific Railway Company, as shown by his original lists, approved by the local officers, and now on file in the General Land Office; and

WHEREAS, the said tracts of land lie coterminous to the constructed line of road, within twenty miles thereof, and are particularly described as follows, to-wit:

Mount Diablo Meridian-Nevada.

Township twenty-one north of Range nineteen east.

Sections one and three, the Lots end and two, the south half of the northeast quarter and the southeast quarter of Section five, the east half of section nine, and sections twenty-five and thirty-five;

Township twenty north of Range twenty-three east.

Sections three, five, seven and nine, the Lot one, the north half of the southwest quarter and the west half of the northwest quarter of Section fifteen, the Lots one, three and four, the northwest quarter of the southwest quarter, the north half of the southeast quarter and the north half of Section seventeen, Section twenty-five, the Lot three, the southhalf of the northeast quarter, the southeast quarter and the west half of Section twenty-seven, and Sections twenty-nine, thirty-one, thirty-three and thirty-five;

Township nineteen north of Range twenty-five east.

Sections one, three, five, seven, nine, eleven, thirteen, fifteen, seventeen, nine teen, twenty-one, twenty-one thirty-one three, twenty-five, twenty-seven, twenty-nine thirty-three, and thirty-five;

Township twenty north of Range twenty-five east.

The Lots, one, two, three, four, five and six, the south half of the northwest quarter, the north half of the southwest quarter of Section twenty-nine, the northeast quarter, the north half of the southeast quarter and the Lots one, two, five and

seven, the south half of the north-east quarter, the north half of the southeast quarter and the southeast quarter of the northwest quarter of Section twenty-three, and the Lots one, two, three, four five and six the southwest quarter of the north-east quarter and the northwest quarter of the southeast quarter of Section twenty-five;

Township thirty-four north of Range sixty-eight east.

Sections one, three, five, seven, nine, eleven, and seventeen, and the Lots one, two, three, four, five and six and the northeast quarter of Section nineteen:

NOW KNOW YE, That the UNITED STATESOF AMERICA, in consideration of the premises, and pursuant to said Acts of Congress. HAS GIVEN AND GRANTED, and by these presents DOES GIVE AND GRANT, unto the said Central Pacific Railway Company, successor in interest to the Central Pacific Railrad Company, its successors and assigns, the tracts of land listed as aforesaid and described in the foregoing; TO HAVE AND TO HOLD the said tract with the appurtenances thereof, unto the said Central Pacific Railway Company, successor as aforesaid, and to its successors and assigns, forever.

IN TESTIMONY WHEREOF, I, Woodrow Wilson President of the United States of America, have caused these letters to be made Patent, and the Seal of the General Land Office to be hereunto affixed. GIVEN under my hand, at the City of Washington, the ninth day of November in the year of our Lord one thousand nine hundred and fifteen and of the Independence of the United States the one hundred and Fortieth.
