

AFFIDAVIT OF POSSESSORY CLAIM

Flora D.Hobart being first duly sworn according to law deposes and says:That she claims the following described public lands situated in the County of Eureka, State of Nevada, under that certain Act of the Legislature of the State of Nevada, entitled "An Act prescribing the mode of maintaining and defending possessory actions on public lands in this State." (Approved March 9, 1865,) which said possessory claim and the lands comprising the same are particularly described as follows to-wit:

That affiant has taken no toher claim under this Act;that said claims are not claimed under and existing title except the right and possession of affiant,who now legally occupies,and who some time ago settled upon the said land,has the same under fence and a building thereon,whic is occupied by affiant at different times of the year and also by persons employed by affiant.

That affiant has placed improvements upon said lands which partake of the realty,in this,to-wit:

That affiant has fenced said land,built a cabin thereon,all of which said improvements are of no value for more that Two Hundred(\$200.00)Dollars.

That affiant has had the County Surveyor of Eureka County make a survey of said lands,and that there is attached hereto the plot of such survey duly certified to by the said Surveyor,which said plot and certificate of said Surveyor are attached hereto and made a part hereof.

WHEREFORE,affiant gives notice to all persons that she claims the lands herein above described and plotted upon the plat attached hereto as a possessory claim under the Act above referred to.

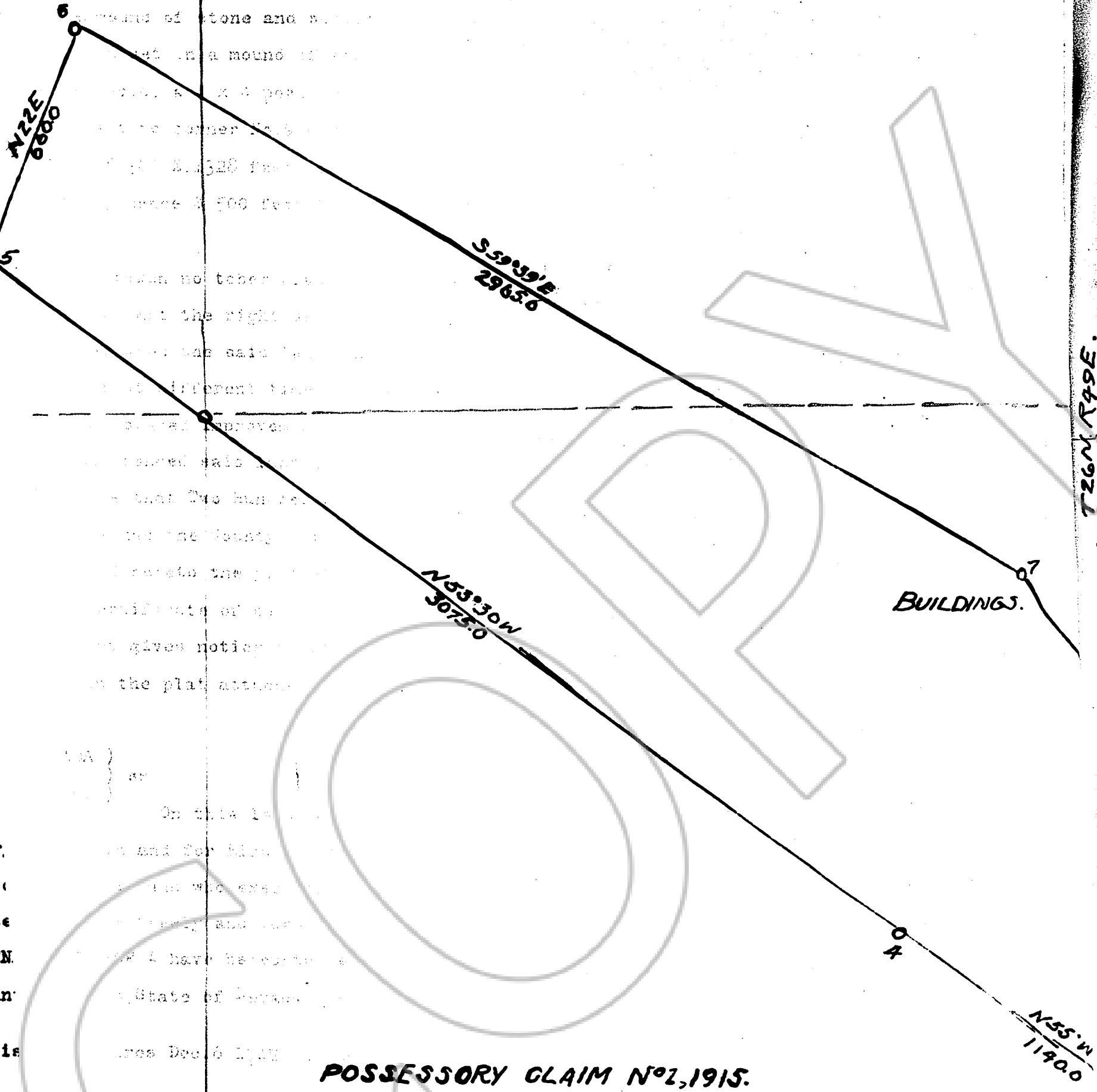

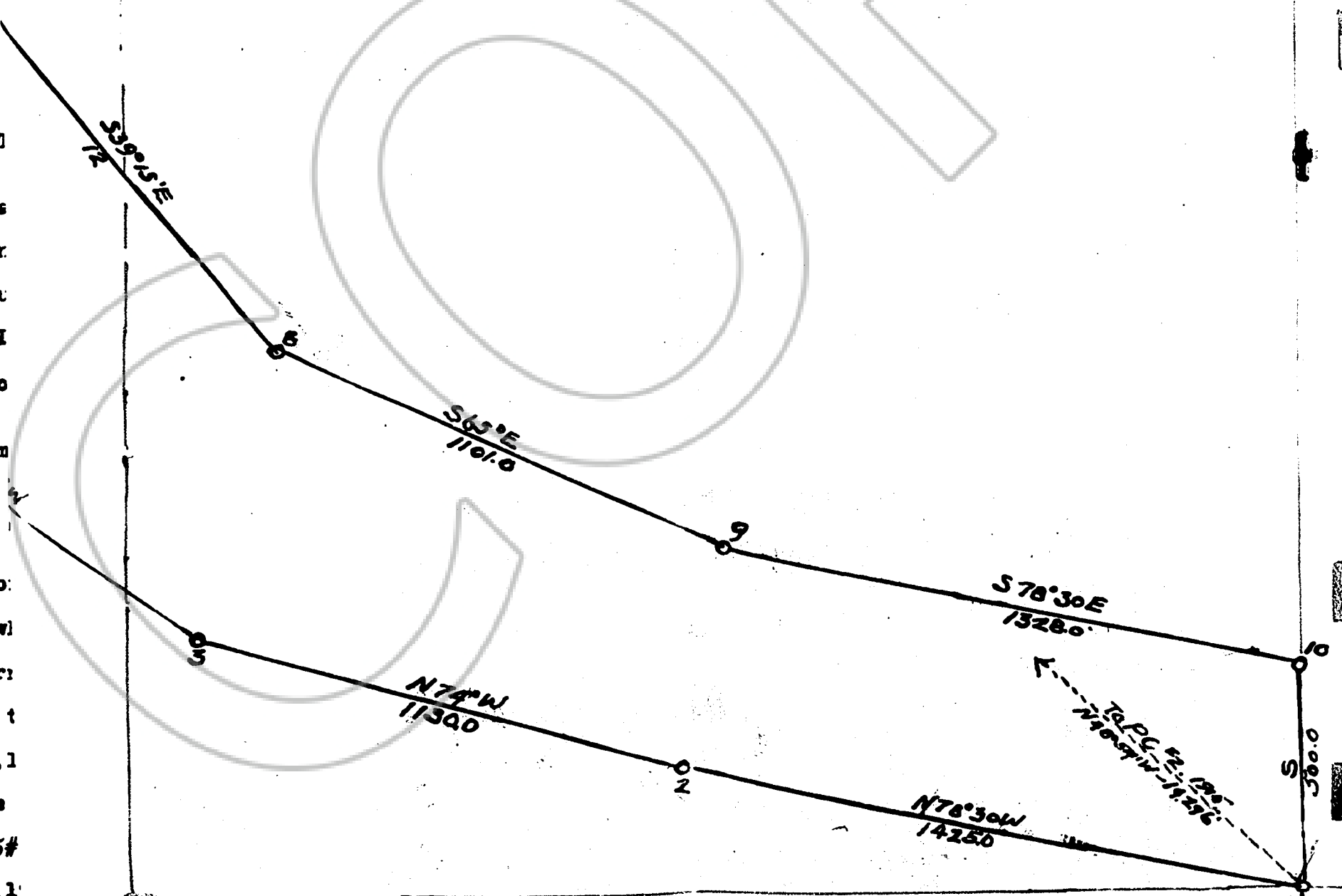
