The above entitled cause came on regularly for trial on this 21st day of August, 1916, before the above entitled Court, the Hon. E.S. Farrington presiding and plaintiffs appearing by their attorney, Perry Evans, Esq., and the defendants appearing by their attorney, Geo. B. Thatcher, Esq., and the cause having been submitted upon the offer of judgment contained in the Answer of the defendants:

Now, Therefore, it is hereby ordered, adjudged and decreed that the assessment for the county of Eureka, for the year 1914 mentioned in the complaint of the plaintiffs is void to the extent that it exceeds Three Hundred Ninety-one Thousand Four Hundred Forty Dollars (\$391,440); that the assessment for the county of Lander for the year 1914, mentioned in the complaint of the plaintiffs is void to the extent that it exceeds One Hundred Seventy Thousand Nine Hundred Seventy-six Dollars (\$170,976); that there is still due from the plaintiffs upon their taxes for the said county of Lander for the said year 1914, the sum of Three Hundred Nineteen and 46/100 Dollars (\$319.46); that there is nothing due from the plaintiffs upon their taxes for the said county of Eureka for the said year 1914, and that the defendants have and recover of the plaintiffs their costs herein, taxed at the sum of \$\_\_\_\_\_.
