KNOW ALL MEN BY **THESE PRESENTS**, that Charles H.Hale and Mary L.Hale, his wife, of the County of Eureka, State of Nevada, the parties of the first part, for and in consideration of the sum of ten dollars (\$10.00) gold coin of the United States to them in hand paid by George W.Goodfellow, of the County of Eureka, State of Nevada, the party of the second part, do by these presents sell, assign, transfer, set over, convey and deliver unto the said party of the second part, and to his heirs and assigns forever, all personal property of whatsoever kind, character and description, owned by or belonging to said parties of the first part, or either

of them, in the County of Eureka, State of Nevada, or in which they or either of them have any interest including all cattle and livestock of every kind owned by said parties of the first part or either of them, whether branded or not, and including also the "L" brand and iron, and all other brands and irons belonging to said parties of the first part, and including all cattle and livestock branded with "L" brand on both hips, or on left hip, and including all cattle and livestock branded with either or any of the following brands: **U** on left hip; **Q** on left hip; **L** on right ribs; **72** on right ribs; **P** on right shoulder, or on left shoulder, or on left thigh; and including all cattle and livestock earmarked by right ear being cropped close to head; said cattle and livestock being on or near the so-called Charles Hale Ranch (formerly known as the Paul Lane Ranch) in said County, which ranch property is also described in a conveyance of even date herewith from the parties of the first part herein; and including all cattle and livestock branded or earmarked with either or any of said brands or marks belonging to said parties of the first part or in which they have any interest, right, title or claim, and whether upon and around said Ranch or elsewhere, and whether within said County of Eureka or outside said County; also all the brands and irons above mentioned and described and any other brands owned by said parties of the first part; and including all farming tools, implements and machinery of every kind and character, and all corrals for corralling stock of every description that are owned or claimed by said parties of the first part, and including all hay on said ranch.

AND INCLUDING all and singular the personal property, chattels, goods and effects of whatsoever kind, character and description, whether herein mentioned or referred to, situate in said County of Eureka (and cattle and livestock outside of said County as herein referred to).
