Thomas, parties of the first part, and SWEENEY & MOREHOUSE. a law partnership, parties of the second part, WITNESSETH: That whereas, the Assessor and Tax Receiver of the County of Eureka, State of Nevada, sold at tax sale, a certain mining claim and millsite, situated in the County of Eureka, aforesaid, known as and called the Good Hope Mine and Millsite, to one Thomas Dixon, and whereas, at the

time of said sale said mining claim was owned by the said Estate of Thomas Wren, deceased, and it is now necessary that suit be brought for the recovery of said property from said Thomas Dixon, for the said estate, and whereas, the District Court of the Second Judicial District of the State of Nevada, in and for the County of Washoe, being the court in which said estate is being administered, has made an order authorizing such suit, and also made and order authorizing the parties of the first part to employ said Sweeney & Morehouse to prosecute said suit,
