WHEREAS JAMES GREEN FORD of Eureka County Nevada has deposited with the REGISTER OF THE STATE LAND OFFICE at Carson City the STATE TREASURER'S RECEIPT, whereby it appears that full payment has been made by the said JAMES GREEN FORD, according to the provisions of an Act of the Legislature, approved March 12,1885, entitled "An Act to rpovide for the selection and sale of lands that have been or may hereafter be granted by the United States to the State of Nevada, "and the Acts amendatory thereof and supplementary thereto, for the South East quarter of the North East Quarter and the North East quarter of the South East quarter of Section Thirtyfive (35), the South West quarter of the North West quarter and the North West quarter of the South West quarter of Section Thirty-six(36), Township Twenty-one(21) North, Range Fifty(50) East. Mount Diablo Base and Meridian, containing One Hundred and Sixty acres, according to the Official Plat of the survey of the Public Lands, as made by the United States Surveyor-General for the District of Nevada, which said tract has been purchased by the said JAMES GREEN FORD. THEREFORE, KNOW YE, That the State of Nevada, innconsideration of the premises, and in conformity with the Act of the Legislature in such cases made and provided, has given and granted, and by these presents does give and grant unto the said JAMES GREEN FORD and to his heirs, the said tract above described, to have and to hold the same, together with all rights, privileges, immunities and appurtenances of whatever nature thereunto belonging, unto the said JAMES GREEN FORD and to his heirs and assigns, forever; provided, that all mines of gold, silver, copper, lead, cinnabar, and other vlauable minerals which may exist in the said tract are hereby expressly reserved.
