DECREE OF DISTRIBUTION.

Sarah Z.McIntosh, the duly appointed, qualified and acting Administratrix of the Estate of George McIntosh, deceased, having presented to the Court for settlement her final account and

and report of her administration, and which said final account showed charges in favor of said Estate from the date of her first annual account, two-wit, March 1,1915, to date amounting to \$11,693.73, claiming credit during said peroid amounting \$9351.81, leaving a balance of \$2152.67 in her hands belonging to said Estate, and she lhaving proved to the satisfaction of the court that said account and report was filed on the 13th.day of October, 1916. That due notice of the hearing thereof was given according to law and no person appearing to except to or contest said account and the Court having heard the evidence, finds said account correct, and that all claims set forth in the accompanying report were justly due and payable out of said Estate and have been paid.

IT IS THEREFORE ordered, adjudged and decreed by the Court that said account be in all respects approved, allowed and settled.

And the said administratrix at the same time and place having filed in this Court her petition for distribution, together with her petition setting forth that said Estate was in a condition to be closed, and that a portion of said Estate remains to be divided among the heirs. Devisees and legatees of said Estate, and praying that said residue be distributed to the parties entitled thereto.

And it appearing to the satisfaction of the Court that due and legal notice was given of the hearing of said petition as required by law; and that all taxes upon the property of the Estate has been fully paid and that the residue of said Estate consisting of the property here inafter particularly described is now ready for distribution and that said Estate is now in a condition to be closed, and it further appearing that the said George McIntosh died testate in the County of Elko, State of Neveda, on the 28th.day of October, 1913, and that by the terms of said will of the said deceased, he bequesthed specific money legacies as follows; to his brother John A. McIntosh, the sum of \$2500, to his nephew, Dr. Arthur McIntosh, the sum of \$2500, to his nephew, C.H. McIntosh, the sum of \$650 and to his friend Owen W. Tucker, his choice and pick of any horse that said deceased may own at the time of his death to be selected as soon as the Estate has been inventoried, and to his wife, Sarah Z. McIntosh, (the administratrix herein), the home in the town of Carlin, together with all the household goods, furniture and personal effects therein of every nature, kind and description, and all the rest, residue and remainder of his Estate of every nature, kind and description whereever situated consisting of both and real and personal property unto my wife Sarah Z. McIntosh, (the Administratrix herein),

And it appearing to the satisfaction of the Court that all of said legacies and bequests, in cash and personal property have been paid and turned over to the legatees in said will, and as evidence by the assignments and receipts therefor filed in said Court;

And it further appearing that vouchers have been filed herein showing that all expenses of administration and all claims have been paid by said Administratrix, and that Sarah Z.McIntosh, wife of said deceased, is entitled to the residue of said Estate;

Now on motion of B.F. Curler, counsel for said Administratrix, and no objection being made there to, IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the residue of said Estate of George McTosh, deceased, hereinafter described, and now remaining in the hands of said Administratrix, and any other property which may belong to said Estate, or is which said Estate may have any interest be, and the same is hereby distributed to Sarah Z.McIntosh, widow and residuary legatee of said George McIntosh, deceased.

The following is a particular description of soid Estate referred to in this decree and of which distribution is ordered, adjudged and decreed as aforesaid, to-wit; Lots 15 and 16 of Block #3 of the Town of Carlin, County of Elko, State of Nevada, together with the buildings thereon, also one-half interest in the Lone Star No.1 and one-half interest in the Lone Star No.2 lode mining claims, situate in Lynn Mining District, Eureka County, Nevada, also all money in the hands of the said Administratrix as set forth in said final account and all the rest and residue of

said Estate consisting of choses in action, book accounts, and all other real and personal property belonging to said deceased at the time of his death.
