And the said account and petition this day coming on regularly to be heard, and Hanna Mackey, sole heir having given her consent to the hearing of the petition without publication of notice.

And it appearing that said account is in all respects true and correct, and that it is sup- ported by proper vouchers; that there is no residue of money in the hands of the administratrix at the time of filing said account; that the sum of \$46.50 has been advanced by the heirs for the purposes of paying the expenses of administration and that the sum of \$46.50 has been expended by her as necessary expenses of administration, the vouchers whereof, are now presented and filed, and is now settled and allowed, and the payments are approved by this court; and it appearing that there was not any claims filed against the estate and that there was not any debts against the deceased, and that all taxes on said estate and expenses and charges of administration had been fully paid and discharged, and that said estate is ready for distribution, and in condition to to be closed.

It is further ordered, adjudged, and decreed, that the said final accounts of the said ex- cutrix be, and the same are, settled, allowed, and approved, and that the residue of said estate hereinafter particularly described, and any other property not now known or discovered, which may belong to the said estate, or in which the said estate may have any interest, be, and the same is hereby, distributed as follows;

All of said property to be distributed to his daughter, Hannah Mackey.

The following is a particular description of the said residue of said estate referred to in this decree, and of which distribution is now ordered as aforesaid:

Lots No. 1, 2, 3, and 4 in block 29 of the town of Eureka, state of Nevada, and 66 2/3 feet in the Colorado Mine, Patented, situated in Eureka Mining District, county of Eureka, state of Nevada.

And any and all property which may hereafter be discovered belonging to said estate.
