James Mackey, Administrator of the estate of Herbert Davis, deceased, having on the 30 day of June, 1922, rendered and filed herein a full account and report of his administration of said estate, which account was for a final settlement, and having with said account filed a petition for distribution in said estate;

And the said account and petition this day coming on regularly to be heard, and notice of the hearing of the said account and petition for distribution having been dispensed with as provided by law in cases of summary administrations;

And it appearing to the Court that said account is in all respects true and correct, and that it is supported by proper vouchers; that there is not any residue of money in the hands of the administrator at the time of filing said account; that the sum of \$71.50 has been advanced by the heirs for the purpose of paying the administration expenses, and that the sum of \$71.50 has been expended by him as necessary expenses of administration, the vouchers whereof are now presented and filed, and is now settled and allowed, and the payments are approved by this Court; and it appearing that there was not any claims filed against the said estate, and that there was not any debts against the deceased, and that all taxes on said estate, and expenses and charges of administration have been fully paid and discharged, and that said estate is ready for distribution, and in condition to be closed.

IT IS ORDERED ADJUDGED AND DECREED that the said final account of the said administrator be, and the same are settled, allowed and approved, and that the residue of said estate hereinafter particularly described, and any other property not now know or discovered, which may belong to said estate, or in which the said estate may have any interest, be, and the same is hereby distributed as follows:

To D.J.Davis, Son, an undivided one-half of all of the residue of said estate, and to Herbert Davis an undivided one-half of the residue of said estate.

The following is a particular description of the said residue of said estate referred to in this decree, and of which distribution is now ordered as aforesaid:

An undivided interest of 383 2/3 feet in the Colorado lode mining claim, patented, situated in the Eureka Mining District, County of Eureka, State of Nevada.

And any and all property which may hereafter be discovered belonging to said estate.
