ORDER SETTLING FIRST AND FINAL ACCOUNT AND DECREE
FOR DISTRIBUTION.

Alexander Fraser, executor of the estate of Madeline Fraser, deceased, having on the 7th day of December A.D. 1922, submitted and filed herein his first and final account and report of his administration of said estate, which said account was for final settlement, and having with said account filed a petition for final distribution of said estate; and said account, report and petition coming on regularly this day to be heard; proof having been made to the satisfaction of this court that due and legal notice has been given of the settlement of account and the hearing of said petition; and proof having been made to the satisfaction of court that due and legal notice to creditors has been given in accordance with law; whereupon it is ordered, adjudged and decreed that due and legal notice of this hearing has been given in all respect as required by law and that due and legal notice to creditors has been given as required by law.

And if appearing that said account is in all respects true and exact and it is supported by proper vouchers and that there is \$000 on hand at the time of filing said account and since the rendition of said account the executor had received the sum of \$ 000 ; and it appearing that there is not inheritance tax to be paid on the account of said estate; and it appearing that all claims against said estate, all taxes upon the property thereof and all debts and expenses of administration have been fully paid and discharged and that the estate is ready for distribution and in condition to be closed.

And it appearing to the court that the executor has transacted the business of said estate in a satisfactory manner.

NOW THEREFORE, it is ordered, adjudged and decreed that the account herein filed be allowed settled and approved. That the actions of said executor as set forth in said report be, and the same are hereby allowed and confirmed and that the said property of the estate, as well as all other property not now known or discovered that may belong to the estate or in which the estate may have an interest, be, and the same is here distributed unto Alexander Fraser, the devisee named in the will.

The following is a particular description of the remainder of said estate referred to in said decree and for which distribution is ordered, adjudged and decreed.

And it is hereby further ordered, adjudged and decreed that upon the filing of the receipt by the executor of the heir entitled to distribution of said estate, the said executor shall be forthwith discharged of his duties without the further order of this court and that the estate be declared closed.
