

KNOW ALL MEN BY THESE PRESENTS, that I, R.F.RAINE, of the County of Eureka, State of Nevada, the party of the first part, for and in consideration of the sum of Fifteen thousand Dollars (\$15,000.00) lawful money of the United States of America, to me in hand paid by JAMES P. RAINE, of the County of Washoe, State of Nevada, the party of the second part, the receipt whereof is hereby acknowledged, do by these presents, grant, bargain, sell and convey unto the said party of the second part, his executors, administrators and assigns, all that certain personal property described as follows, to-wit:-

All of the live stock now belonging to me wherever situated, together with the brands of said live stock and consisting of two hundred fifty (250) head of cattle, more or less; the said cattle being branded upon either the right or left hip with a Hat brand, thus-"", or a Four T Brand, thus-"4 T"; a hundred (100) head of horses, and mules, more or less; the said horses and mules being branded upon either the right or left shoulder with a Hat Brand, thus- "", or a Four T Brand, thus- "4 T"; also fifty (50) head of hogs, more or less, unbranded; all of said live stock being upon what is known as the J.P.Raine Home Ranch and the J.P.Raine Hay Ranch, in Pine Valley, Eureka County, Nevada, or running upon the range in said Eureka County.

Also all household furniture and farming utensils of every nature and kind situated upon said ranches, including an automobile and automobile truck.

TO HAVE AND TO HOLD the same unto the said party of the second part, his executors, administrators and assigns forever.

And I do for myself, my heirs, executors and administrators covenant and agree to and with the said party of the second part, his executors, administrators and assigns, to warrant and defend the sale of the said property, goods and chattels hereby made unto the said party of the second part, his executors, administrators and assigns, against all other person and persons whomsoever, lawfully claiming or to claim the same.
