Adams H. And it appearing to the Court to its satisfaction from the evidence adduced at such hearing that the said first and final account is in all respects, just, true, and correct, and should be settled as rendered, and that all and singular the allegations and statements contained in said petition for final distribution is and are true, and the Court hereby find them to be true, and that all State and County taxes levied upon the property of the said estate have been paid by said Executor, and that all claims and debts against said deceased and all debts, expenses and charges of administration have been fully paid and discharged.

And if further appearing that 411 of the property of the said estate is the separate property of said deceased.

And itfurther appearing that said Hiram Johnson died testate in the County of Clark, State of Nevada, on the 7th day of January, 1925, and that at the time of his death he was a resident of the County of Eureka, State of Nevada, and that he left surviving the following next to kin and heirs at law, and none others, namely, Adams H. Johnson, SON, and Anna S. Bracken, Daughter.

That due and legal notice of the hearing of the first and final account and cetition for final distribution has been given;

That the said first and final account be, and the same is hereby settled, allowed and approved as rendered; and

Ot is further ordered, adjudged and decreed, that all of the rest residue and remainder of the property, both real and personal, constituting the estate of the said Hiram Johnson, deceased, hereinafter particularly described, and now remaining in the hands of said Executor, and any and all other property which belong to the said estate, or in which said estate may have any interest, be and the same are hereby distributed as follows, to-wit:

To Adams H. Johnson, Son of said deceased, the sum of \$1711.89 in cash; 49,750 shares of stock in the Yellow Jacket Mining Company, of Utah; An undivided one-half interest in and to Lot 2 in Block 21, and an undivided one-half interest in and to Lots 1,2, in Block 3 as laid down and described upon the official map of the town of Eureka, together with an undivided one half interest in and to all improvements located on said lots, and an undivided one-half interest in and to all furniture, fixtures, goods, wares and merchandise contained in the buildings located on said lots. An undivided one-half interest in the Fourth of July lode mining claim, an undivided one-eighth interest in the Silver Commer, Laral, Pioneer, Wabash Fraction, and Hidden Jewel lode mining claims, all situated in the Eureka Mining District, County of Eureka, State of Bevada. Also four hundred eighty one shares of stock in the Remington Johnson Co. of Salt Lake City, Utah.
