SQUIRES, A MINOR CHILD )

It being shown to this Court, in the above-entitled matter, that AARON MOORE, and NANA M. MOORE, his wife, on the 25rd day of November, 1926, filed a petition in said Court for leave to adopt BARBARA COLLEEN SQUIRES, a minor child of the age of two years; that RICHARD SQUIRES is the father of said child, and that AARONA SQUIRES, deceased, is the mother of said child; that the consent of said father, RICHARD SQUIRES, to the adoption of said child is not necessary owing to the fact that a decree of divorce was granted to the mother of said child during the month of September, 1925, by the Judge of the Ninth Judicial District Court of the State of Nevada, in and for the County of White Pine, on the grounds of cruelty; that said petitioners have filed herein an agreement properly signed, before me, that said minor child shall be adopted by said petitioners,

and treated in all respects as their own lawful child should be treated, including the right of inheritance; and the said matter now coming on regularly for hearing, the Court proceeds to an examination of the case, and finds that one of the petitioners have appeared herein, and was examined as provided by law; that said petitioners reside in the County of Eureka, State of Nevada, and that the interest of Barbara Colleen Squires, the said minor child, will be promoted by the adoption;

It is therefore ordered, adjudged, and decreed that the said petitioners, AARON MOORE, AND NANA M. MOORE, his wife, adopt the said child; that henceforth the said minor child shall be treated by them in all respects as their own lawful child should be treated, including the right of inheritance; and that said petitioners and said minor child shall hereafter bear towards each other the relation of parent and child, and that said child shall take the family name, to-wit: BARBARA COLLEEN MOORE.
