BRENNEN, of the County of Eureka, State of Nevada, the party of the first part, for and in consideration of the sum of One Hundred (\$100.00) Dollars, lawful current money of the United States of America, to him in hand paid by MARTIN ELORGA COMPANY, a copartnership, consisting of Martin Elorga, Jose Elorga, Fernanado Segura, Martin Segura, and Marcelino Jusnicotena, of Eureka County, State of Nevada, the party of the second part, the receipt whereof is hereby acknowledged, does by these presents, sell, transfer and set over unto the said Martin Elorga Company, the following described personal property situate in the County of Eureka, State of Nevada, and more particularly described as follows, to-wit:

Twelve Hundred (1200) head of sheep branded ES, together with all increases thereon or additions thereto, which may have been acquired by the said first party, since February 10, 1922. It being the intention of the said first party to sell, transfer and set over, and he hereby does so, unto the said second party all those certain sheep, together with all additions and increases thereto, which were acquired by said first party under a certain Bill of Sale dated February 10, 1922, wherein Martin Elorga and Martin Segura were grantors and William H.
