To all to whom these presents shall come, Greeting:

Where as by the act of Congress approved July 1, 1862, as amended by the act of July 2, 1864, "to aid in the constitution of a railroad and telegraph line from the Missouri River to the Pacific Ocean, and to secure to the Government the use of the same for postal, military and other purposes," and the act of July 3, 1866, authority is given to the Central Pacific Railroad Company "to construct a railroad and telegraph line" under certain conditions and stipulations as expressed in said acts, and provision is made for granting to the Company "every alternate section of public land designated by odd numbers to the amount of ten alternate sections per mile on each side of the said railroad on the line thereof and within the limits of twenty miles on each side of said road not sold, reserved or otherwise disposed of by the United States, and to which a pre-emption or homestead claim, may not have attached at the time the line of said road is definitely fixed". And Whereas, an official statement bearing date November 3, 1869, from the Secretary of the Interior has been filed in this office showing that the line of said railroad and telegraph from Ogden in the Territory of Utah, to Sacramento City, State of California has been constructed and fully completed and equipped in the manner prescribed by the acts aforesaid. And Whereas, certain tracts of land in the State of Nevada have been listed under the acts aforesaid by the duly authorized land agent of said Central Pacific Railroad Company as shown by his original lists approved by the local land offices on file in this Office. And Whereas, the said tracts of land lie coterminous to the constructed line of road and are particularly described as follows, to-wit, North of base line and East of Mount Diablo Meridian, State of Nevada. Township Twenty, Range Twenty-Two, The South East Quarter of the South East Quarter of Section twenty-seven, containing forty acres. The West half of Section thirty-one, containing three hundred and twenty-five acres and sixteen hundredths of an acre. Township twenty-one, Range Twenty-three. The South West Quarter of Section Twenty-five containing one hundred and sixty acres. Township Thirty-five, Range Forty-two, All of Section seven, containing six hundred and twenty-one acres and seventy-two hundredths of an acre. All of Section nineteen, containing six-hundred and twenty acres and sixty hundredths of an acre. Township Thirty-nine, Range Forty-three. The North West Quarter of the North East Quarter and the East half of the North West Quarter of Section twenty-seven, containing one hundred and twenty acres. The east half of the North East Quarter and the North West

quarter of the South East Quarter of section thirty-three, containing one hundred and twenty acres. Township Thirty-eight, Range Forty-four. The East half of the North West quarter, and the East half of the South West quarter of section nineteen, containing one hundred and sixty acres. The South half of the North East Quarter, the South half of the North West quarter and the South half of Section thirty-three, containing four hundred and eighty acres. Township thirty-three, Range forty-seven. The South West quarter of section nine, containing one hundred and sixty acres.

✓ Township Thirty-three, Range Forty-eight. The East half of section Thirty-five, containing three hundred and twenty acres. Township Thirty-four. Range forty-eight. The South West quarter of section three containing one hundred and sixty acres. The North East quarter, the North East Quarter of the North West quarter and the South West quarter of Section seventeen, containing three hundred and sixty acres. Township Thirty-five, Range Forty-eight. All of section twenty-five. Containing six hundred and forty acres. All of section thirty-five, containing six hundred and forty acres. Township Thirty-one, Range fifty. The North half of section seventeen, containing three hundred and twenty acres. Township thirty-four, Range Fifty-one. The North half of the North East quarter of Section twenty-five, containing eighty acres. Township Twenty-eight, Range Fifty-two. The North half of the North East quarter and the North half of the North West quarter of Section seventeen, containing one hundred and sixty acres. Township Thirty-four, Range Fifty-two, All of Section five, containing six hundred and thirty-five acres and sixty hundredths of an acre. All of Section seven, containing six hundred and thirty-seven acres and twenty hundredths of an acre. All of section seventeen, containing six hundred and forty acres. All of section nineteen, containing six hundred and thirty-nine acres and sixty hundredths of an acre. Township Thirty-five, Range Fifty-two. All of section five, containing six hundred and eight acres and forty-four hundredths of an acre. All of section seventeen, containing six hundred and two acres and eighty hundredths of an acre. All of section twenty-nine, containing six hundred and thirty-two acres and forty hundredths of an acre. All of section thirty-one, containing six hundred and twenty-seven acres and fifty-two hundredths of an acre. Township Thirty-six, Range Fifty-two. The lots numbered one and two of the North West quarter the South East quarter of the North West quarter, the South half of the North East quarter and the South half of section nineteen, containing five hundred and nineteen acres and twenty hundredths of an acre. The East half of section twenty-nine, containing three hundred and twenty acres. The West half of the North East Quarter, the West half of the South East quarter and the West half of section thirty-one containing four hundred and eighty acres, and sixty-four hundredths of an acre. Township Thirty-two, Range Fifty-five. The South West quarter of section three containing one hundred and sixty acres. The North West quarter of section twenty-five containing one hundred and sixty acres. Township Thirty-three, Range Fifty-eight. The East half of the North East quarter and the East half of the South East quarter of section twenty-one, containing one hundred and sixty acres. Township Thirty-six, Range Fifty-nine. The South half of the South East quarter of section one containing eighty acres. Township Thirty-eight, Range Fifty-nine. The lot numbered four, the South West Quarter of the North West quarter and the West half of the South West quarter of section one, containing one hundred and sixty acres and eighty-four hundredths of an acre. The East half of the North West quarter of section eleven containing eighty acres. The East half of the North West quarter and the East half of the South West quarter of section thirteen, containing one hundred and sixty acres.

Township Thirty-nine, Range Fifty-nine. The East half of the North East quarter, the East half of the South East quarter, and the South East quarter of the South West quarter of Section thirty-five, containing two hundred acres. Township Thirty-six, Range sixty. The North half, and the South East quarter of Section three, containing four hundred and seventy-seven acres and ninety hundredths of an acre. The said tracts of land as described in the foregoing, make the aggregate area, of thirteen thousand four hundred and sixty nine acres and sixty-two hundredths of an acre (13,469.62) Now Know ye, that the United States of America, in consideration of the premises and pursuant to the said Acts of Congress, Have Given and Granted and by these presents, Do Give and Grant unto the said Central Pacific Rail-Road Company and to its assigns, the tracts of land listed as aforesaid and described in the foregoing: Yet ~~excluding~~ and ~~excepting~~ from the transfer by these presents "All Mineral Lands," should any such be found to exist in the tracts described in the foregoing, but this exclusion and exception according to the terms of the Statute "shall not be construed to include Coal, and Iron lands." To Have and To Hold, the said tracts with the appurtenances unto the said Central Pacific Railroad Company and to its successors and assigns forever. In testimony whereof, I, Grover Cleveland, President of the United States of America, have caused these letters to be made patent and the seal of the General Land Office to be hereunto affixed. Given under my hand at the City of Washington this second day of September in the year of our Lord one thousand eight hundred and ninety-six and of the Independence of the United States the one hundred and twenty-first.
